Once nominated, the student must fill out the application form and upload the required documents: <ul style="list-style-type: none">- Official ID- Transcript of records- Cover letter- Curriculum Vitae (in Spanish)- Academic recommendation letter- Proof of Spanish language level for non-Spanish speaking countries.
Language	B1 level of Spanish language is recommended.
VISA	The student visa (temporary residence) is only required for a stay longer than 180 days (if required, an additional consular letter will be issued along with the letter of acceptance).

<p>Restrictions</p>	<ul style="list-style-type: none"> ● On-site mobility will be determined by national and international provisions due to the health crisis, as well as the institutional contingency measures that the University of Guadalajara defines, therefore mobility could be limited or canceled, even with admission letters issued, attending to the guidelines and requirements determined for such purpose. ● The activities in each University Center will be subject to the resolutions of the General Rector's Office, the Rector's Office of the University Center, and the state and local health authorities. ● If required, the University of Guadalajara will issue the consular letters needed by students to carry out visa procedures.
<p>Transcript of records (TOR)</p>	<p>The grading scale goes from 0 to 100; minimum grade required to pass being 60. Students must attend at least 80% of classes in order to pass the course. The TORs will be sent to the international office of the home university once the academic cycle has ended.</p>

<p>Research stays / Internships</p>	<p>The acceptance for research and internships is subject to the approval of the corresponding University Center.</p>
<p>Clinical electives</p>	<p>For the time being, clinical electives at the Civil Hospital are suspended.</p>

<p>Medical insurance requirements</p>	<p>Students participating in the PEA are required to have international medical coverage during their stay that includes provisions related to medical care for the Coronavirus "COVID-19" (SARS-CoV-2), as well as repatriation of remains. The medical insurance must cover the total number of days of the stay. The student must submit a copy of his/her medical insurance to CI prior to his/her arrival in Mexico.</p>

Cost of the stay	The estimated cost of living is between 500 and 700 US dollars a month. Additional costs should be taken into consideration for unexpected occurrences.
Accommodation	There are no residences provided by the university; therefore, students will have to look for their own accommodation.
Buddy program	The University Center of Economic and Administrative Sciences (CUCEA) a “Buddy program” to guide exchange students.
Airport pick-up	Not available.
Scholarships for exchange students	Not available.
Contingency measures	It is recommended that PEA participants have a complete vaccination record.
