1. GENERAL INFORMATION

- For 90 days, Turkish citizens can enter Argentina without a visa. However, in order to prevent problems, the necessary controls for entering the country must be implemented.
- For stays longer than 90 days, visitors must apply to Argentine Consulates and go through the necessary procedures for a long-term visa.
- Only Argentine Pesos can be withdrawn from ATMs in Argentina against a loan or salary account; foreign currencies such as US Dollars and Euros are not permitted. Transaction and commission costs for cash withdrawals made with Turkish or foreign bank cards are approximately 20% of the withdrawn amount.
- It is illegal to bring more than \$10,000 (ten thousand) USD into or out of Argentina.
- To begin the visa application process, please contact the appropriate [Consular Office](#) to schedule an appointment and submit the necessary documents.

The following documents should be carried by the person traveling to Argentina:

- Passport valid for **at least 6 months** from the return date of travel and with 1 blank page in order for the gate visa to be issued
- Copy of identity card
- Accommodation documents
- Transportation documents
- Travel Health Insurance (**30.000 EUR guaranteed**)
- Invitation to be sent by someone living in Argentina
