1. GENERAL INFORMATION

- The Cuban visa is a single-entry visa. It loses its validity after entering and leaving the country because it only allows you to stay for 30 days in a 6-month period. If it is desired to re-enter Cuba and it is not possible to return to Turkey, a Cuban visa sufficient for re-entry is required.
- Passports that are worn can be a problem.
- T.C. Turkish citizens with special, service, or diplomatic passports are not required to obtain a visa to enter Cuba. Public (red) passport holders, on the other hand, must obtain a visa before traveling to Cuba.
- Visa applications for Cuba are submitted online. A visa application form, a color-scanned passport, and a round-trip flight ticket reservation can be submitted to the Cuban Consulate/Embassy.

- As from 1 May 2022, payment for consular services shall be made only in euros, through a bank. Cash will not be accepted.
- Deposits in the bank account must be in the exact amount required by the consular procedure; they do not accept amounts less or greater than the required amount. If the deposit amount is not exact, it will be returned to the client, who will have to make the deposit again in order to complete the corresponding procedure.
- Once the amount has been deposited in the bank account of **KÜBA CUMHURİYET'İ BÜYÜKELÇİLİĞİ, IBAN: TR90 0001 0015 3597 5721 2050 02**, at **Ziraat Bankasi Bank** for consular procedures in our bank account, users have up to 6 MONTHS to apply to the Consular Office for the service.
- Consular services will be carried out directly or remotely by post. The procedures will be sent by post via YURTICI KARGO, PTT, DHL, MNG and UPS.

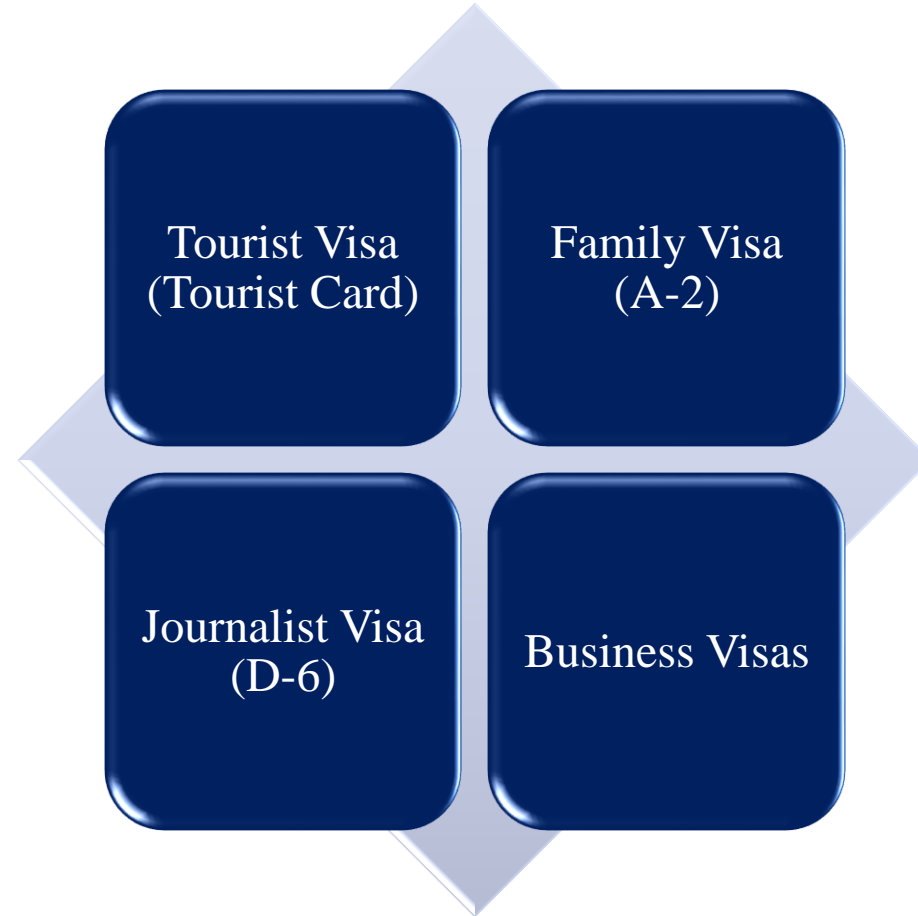

4. TOURIST VISA

The tourist visa or tourist card is only used for trips of foreign citizens who wish to make tourism to Cuba. Valid for a single entry to the national territory on a 30-day trip and you can extend 30 days at the hotel desk where you are staying or before the immigration authorities. Underage must have their tourist card even if they are registered in the parents' passports.

Documents needed to obtain directly from the consulate:

- Valid passport
- Form
- Plane ticket with arrival and return date
- Must pay the consular fee stipulated for this service

Documents needed to obtain it by postal mail

- Legible photocopy of the valid passport
- Legible photocopy of the flight ticket with date of entry and return
- Must pay the consular fee stipulated for this service
- Envelope with sufficient stamps and return address

NOTE: If the request is made by mail or through a third person, the consular fee stipulated for this service will be charged in addition.

All payments must be made in cash, by means of payment certified bank or bank transfer. The cash sent by mail will be rejected and returned at the risk of the applicant.
