1. GENERAL INFORMATION

- Although Iran does not require a visa for tourist visits of up to 90 days for citizens of the REPUBLIC of TURKIYE, they want to see flight ticket reservation and accommodation information. As a result, those planning a tourist trip to Iran should prepare transportation records ahead of time to avoid problems at the border. Aside from Turkey, public passport holders from Azerbaijan, Bolivia, China, Armenia, Georgia, Hong Kong, Lebanon,
 - Macau, Malaysia, Egypt, Syria, Oman, and Venezuela can visit Iran without a visa for varying periods.
- Visas can also be obtained at some airports when entering Iran. For flights arriving at Konarak Airport, Isfahan Airport, Kish Airport, Mashhad Airport, Bandar Abbas Airport, Shiraz Airport, Tabriz Airport, Imam Khomeini International Airport, Kerman Airport, Laristan Airport, Ahvaz Airport, Mehrabad Airport, and Urmia Airport, a visa can be obtained for a fee.
- Only Lebanese citizens are eligible for a free airport visa.
- Afghanistan, Bangladesh, Canada, Colombia, Iraq, India, Jordan, Pakistan, Somalia, the United Kingdom, and the United States are among the countries that are not eligible for airport visas. For any travel, citizens of these countries must apply for a visa in advance.



2. IRAN VISA RULES

- Female applicants over the age of nine must follow specific rules for visa processing. They must provide a photo of themselves wearing a headscarf for their visa application.
- Israeli citizens are not permitted to enter Iran. Furthermore, if your passport contains an Israeli stamp, you may be denied entry into Iran.
- Please keep in mind that entry requirements may change based on government decisions, and it is strongly recommended that you obtain solid information from the local diplomatic missions in your country of residence prior to your departure.



3. DOCUMENTS REQUIRED FOR VISA APPLICATIONS

- 1. A passport or travel document with at minimum two blank pages, valid for at least six months and for at least 90 days after the end of travel. Copy of the first page including personal data and previous visas if obtained.
- 2. Completed and signed visa application form along with two biometric photo that is not older than 6 months.
- 3. Passport copy and personal photo requirements for the e-visa applications should be in line with the guidelines provided <u>online</u>.
- 4. Proof of travel with confirmed both-way tickets.
- 5. Bank account details proving that the passenger can sufficiently fund his/her travel.
- 6. It is important that the applicant does not pose any threat to the public health, security, morals, or the national economy. Hence, the applicant should not be accused or convicted of a crime.
- 7. Evidence of occupation in the form of certified documents through employer letter, student certificate, document of registration or demonstration of pension funds.
- 8. Accommodation details through an invitation letter or proof of your hotel reservation throughout your stay.
- 9. A letter of intent summarizing the applicant's main reason requesting an entry permit to Iraq, the total length of scheduled stay, name of places to be visited, contact and accommodation information.

10. Documentation of travel health insurance.

Employed:

- Employment contract (original certificate of employment indicating the position in the company and the salary)
- Bank account statement of the past 6 months
- Approval letter of leave from employer
- Income Tax Return (ITR)

Student:

- Documentation of University enrollment
- No-objection certificate from school management
