## 1. GENERAL INFORMATION

• Israel is among the countries that issue different visa types depending on your purpose of travel and the number of days you will spend in the country. While public (red) passport holders are obliged to obtain a visa, special, service and diplomatic passport holders can visit the country exempt from visa for a period not exceeding 90 days within a 180-day period.



## 2. ISRAEL VISA REQUIREMENTS

- Citizens of the Republic of Turkiye who wish to visit the State of Israel must apply for a visa online through the Israeli Consulate General.
- The passport must have at least two blank pages when presented to the consulate during visa procedures.
- For the person visiting the State of Israel, the passport must be valid for at least 6 months from the date of presentation.
- During visa applications, only passports approved by the authorized persons in the Israeli Consulate are valid in return for the 'passport delivery receipt'.
- Applicants who will visit the country are expected to fulfill the visa application conditions in full.
- The State of Israel does not impose a requirement that an application must be made in person by those who will visit the country. It is also possible to apply for a visa through institutions authorized by the Consulate to provide visa services.



### 3. GENERAL VISA APPLICATION DOCUMENTS

- Passport with at least 6 months validity
- Biometric photograph (5x5) taken within the last year
- Application form for Israel visa
- Copy of identity card
- Apart from these standard documents
- If the person has property on him, documents indicating ownership such as a copy of the title deed, license
- Bank passbooks
- Bank account statement (must have a balance of at least 5,000 TL in the account)
- Employees must submit current documents to the consulate to demonstrate that they are paid on a regular basis. Employment notice, last three months' payroll, service breakdown etc.
- Workplace petition: A stamped and signed petition prepared on company letterhead and addressed to the Consulate General of Israel by a company official, detailing the dates you will be off from work between the dates you will be in Israel, as well as payroll for the previous three months. Transcript of SGK 4A service Documents such as a certificate of activity, a photocopy of the certificate, a photocopy of the circular of signature, an employment registration, a tax plate, and a registry newspaper must be submitted to the Israeli Consulate during visa applications.
