1. GENERAL INFORMATION

- For stays of up to ten days, visitors must show financial assets equal to 90% of the gross national minimum wage. For stays of more than ten days, the daily charge is 70.77€ (2020).
- Citizens of European countries are entitled to visa-free travel within the borders of the European Union. As a result, EU citizens who wish to visit Spain can do so with their ID cards and without a visa.
- For tourist or business purposes, as well as airport transits for stays of up to 90 days, US citizens with US passports valid for at least three months from the intended return date from Spain, no visa is required.
- The United Kingdom is not a member of the Schengen area. Furthermore, UK citizens will no longer have the right to free movement in the European Union after the UK officially exits the EU on January 31, 2020. Following a possible post-Brexit transition period, the details will be formalized. During this time, however, UK citizens retain the right to travel within the EU with their UK passports.
- Canadian citizens are not required to obtain a visa to visit Schengen countries for stays of up to 90 days within a 180-day period.

3. VISA APPLICATION REQUIREMENTS

- Being a member of the European Union and Schengen group, Spain, which requests visas from the citizens of the Republic of Turkiye, wants the applications to be made preferably in person. For most visa types, an appointment must be made at least 15 days in advance for individual applications to be made from the consulates in Istanbul or Ankara.
- When you are called to the Spanish Embassy or Spanish Consulate, the requested documents must be handed in and delivered completely.
- During visa procedures, your passport must be taken within the last 10 years and must be valid for at least 3 months and 15 days. Apart from the passport, other required documents must be received within a maximum of 3 months. Older documents will result in visa refusal.
- Candidates who have not applied for a Schengen visa before have to create a fingerprint in their application with the date of 25.09.2014.
- Spain, which seeks at least 10 years in passport validity, does not issue visas to holders of older passports.

4. GENERAL DOCUMENTS REQUIRED FOR SPAIN VISA APPLICATIONS

- The unemployed, insured employees, doctors, craftsmen and self-employed persons, lawyers, pharmacists, engineers, dentists, students and company owners who want to travel to Spain have to apply for a visa together with the documents requested from them.
- These documents;
- Passport (must have a chip passport taken within the last 10 years at the time of visa application and have at least two blank pages)
- Spain visa application form (must only be signed by the applicant)
- Copy of ID (it is necessary to have a clear Turkish ID number)
- Transportation Information (With whichever vehicle to go to Spain, there are documents such as documents, tickets)
- Information on the address to stay (if hotel or similar accommodation will be provided, stamped and signed hotel reservation documents)
- A copy of an invitation from the family for family, friend visits or non-commercial invitations, and a copy of the invitation sent by the inviting company to the person who will travel, in case of commercial travel
- Visa request petition details (if you are working as an insured in a company, the stamp printed on the company's letterhead and the original of the petition signed by the company representative. The same documents if you are a company partner or sole official of the company)
- Overseas travel health insurance (Minimum value of 30,000 Euros)
- Bank account (company and personal detailed account statement at the bank covering the last 6 months and received at most 1 week before the visa application date)
- Workplace documents (documents that employers and employees have to prepare; photocopy of current tax plate, original chamber and activity certificate taken from the chamber of commerce to which your partner or company is affiliated, circular of signature, copy of the commercial registry newspaper with the company information published in the Trade Registry Official Gazette)

- Workplace documents for employees (up-to-date, barcoded copy of tax plate, original activity certificate with wet signature and stamp belonging to the chamber of commerce of the company you work for, circular of signature, photocopy of the page of the company information in the trade registry gazette, with barcode from the accountant or the General Directorate of Social Security). SGk employment entry document, barcoded Sgk registration and service statement from e-government, wet stamped payroll samples of the last 3 months before the application and signed by the company official)
- For farmers, the last 3 months farming certificate obtained from the agricultural chambers, the professional approval certificate obtained in the last 3 months, the barcode SSI service and registration statement from the e-government, the capacity report document
- For retirees, the original document showing the pension and the bank statement taken within the last week
- Original record of the bar association for lawyers
- Original Medical Chamber Record for dentists
- Photocopies of diplomas for pharmacists
- If there are places such as houses and land owned, their title deed photocopies and vehicle licenses, if any.
- For those who provide interest and rental income, a photocopy of the lease contract and if the rent is paid by bank, a stamped signed bank statement covering the last 6 months in which the rent is paid, and a copy of the signature circular of the officer who signed this statement. If interest income is provided, a 6-month stamped and signed time deposit account statement from the bank, a document showing that the interest is paid, and a copy of the bank's circular of signature
