## 1.GENERAL INFORMATION



- As of September 26, 2018, the Netherlands visa application form must be completed online. The Netherlands visa application form can be filled out in Turkish, English, or Dutch.
- As of February 2, 2020, applicants can apply for a Type C Schengen visa up to 6 months before departure.
- Those who have previously provided fingerprints to enter Schengen member states do not need to apply in person as of September 25, 2014.
- If you have a valid passport, the third party to whom you have delegated power of attorney can process your application on your behalf.
- Fingerprints required for passports and ID differ from those required for visas. As a result, if you have never given fingerprints for a Schengen visa, you must apply in person.
- When it is deemed necessary, Dutch consulates may request an appointment from applicants.
- Non-EU nationals who are not obliged to have an entry visa for visits to the Netherlands will nonetheless be required to ask for prior authorization to travel to the Schengen area as of 2021. The authorization can be processed online through the European Travel Information and Authorisation System (ETIAS).



#### 2. DOCUMENTS REQUIRED FOR THE VISA APPLICATION

- Passport (Passports must be issued in the last 10 years, must be valid for at least 3 more months from the return date of travel, and must have at least 2 blank pages side by side.)
- Originals of previously used passports, if any
- Netherlands visa application form (Completely and correctly filled application forms must be wet signed.)
- 2 biometric photographs (photos that should measure 3.5x4.5 cm must be taken within the last 3 months, have a white background and have not been used for visa procedures before.)
- Copy of identity card
- Certified population registration sample (Can be obtained from the Civil Registry Office or e-government.)
- Travel Health Insurance policy (Documentation of travel health insurance that will cover up to 30.000 euros throughout the period of travel and is valid within the entire Schengen area.)
- Netherlands flight and accommodation information (Reservation transcripts of the hotel you will stay in Netherlands and printouts of flight ticket reservations must be shown at the time of application.)
- Bank account statement (Account statements showing the financial situation should reflect the last 3 months. Account statements should be submitted with wet signature and stamp.)
- 4A SGK breakdown (valid only for insured employees)
- Payroll for the last 3 months (Only for insured employees)
- Signature circular of the working company
- Tax plate (Applicable to employers only)
- Activity certificate or Commercial Registry Certificate for the last 3 months (valid for employers only)
- Photocopies of title deeds and lease contracts, credit cards and vehicle licenses, if any
- Invitation letter that can be requested from the municipality, if any
- Visa sponsor petition (valid for those with insufficient financial income)
