1. GENERAL INFORMATION

• The UAE has many bilateral or multilateral visa agreements with various countries around the world, which eliminates lengthy visa processes. Citizens of these countries are allowed to stay in the United Arab Emirates for 30 days or 90 days within a 180 days period starting from the date of first entry, given that they do not take up employment.

• The countries listed on the following page are eligible for visa-free entry into the UAE.

- * Countries that can obtain a visa on arrival that is valid for 30 days with a 10-day grace period for an extension. An extension would be 60 days from the first day of the entry.
- ** Countries that can obtain a visa on arrival that is valid for 90 days and extendable.
- *** Indian citizens with UK or EU residence permits, US visas or green card can obtain an extendable visa on arrival that is valid for 14 days.
- **** Gulf Cooperation Council states that are eligible for a visa-free entry to the United Arab Emirates.

Other listed nationalities can obtain a visa for 90 days within a 180 days period whereas non-listed nationalities have to apply for a United Arab Emirates visa beforehand with varying regulations and requirements.

A student planning to study at a higher education institution, have a language course, or long-term internship and an academic, researcher or scientist to work in a certified United Arab Emirates research center should apply for a D Type (Long-Term) Visa.

Required Documents

- 1. United Arab Emirates visa application form
- 2. 2 biometric photographs (taken in the last 6 months, on a white background, with a clear view of the face and neck area)
- 3. Bank receipt paid for the visa fee (If the receipt is not shown, the application will not be accepted)
- 4. Passport (Color scan of the 2nd and 3rd pages of the passport, which is not worn, torn and valid for at least 6 months more)
- 5. Identity card (Back-sided color scan)
- 6. Accommodation and round-trip flight ticket reservation documents
- 7. Invitation letter
- 8. Bank statement/wallet of the last 3 months (Account statement with the current date and the required amount of balance can be obtained using the internet branch)
- 9. Visa request petition (Company letterhead must include the departure/return date, purpose of travel and the company's permission. (Valid for insured employees)
- 10. Tax plate, Trade Registry Gazette, activity certificate, SGK or Bağ-Kur service breakdown (Valid for employers)
- 11. Marriage certificate (Valid for housewives traveling with their spouse)
- 12. Student certificate (Up to date, valid for students)
- 13. Sponsor petition (Valid for students)
