# 1. GENERAL INFORMATION

- Citizens of the Republic of Turkey holding a public (red) passport and third country nationals holding a Turkish residence permit who want to travel to the People's Republic of Bangladesh are obliged to apply for a visa to the Bangladesh Consulate in order to enter the country.
- Pursuant to the Visa Exemption Agreement signed between Turkey and the People's Republic of Bangladesh on November 12, 1987, the citizens of the Republic of Turkey holding Special (Green) Passports, Diplomatic (Black) Passports and Service (Gray) Passports, which are accepted as Turkey's official passports, have 90 days within 180 days. There is no obligation to apply for a Bangladesh visa to the Bangladesh Consulate for travels not exceeding the limit.
- Bangladesh visa can be obtained with complete and ideally organized visa application documents. You can get your visa from the Bangladesh Consulate, or the visa centers authorized by the Bangladesh Consulate.

- The Consulate General of Bangladesh in Istanbul determines the visa category, type of entry and duration of stay upon receiving and assessing an application.
- The category and type of visa vary according to the purpose of visit, length of stay and bilateral arrangements.
- Bangladesh origin foreign nationals (except SAARC countries), their children and spouse are eligible to obtain No Visa Required (NVR) stamp in their passports to visit Bangladesh.

## 2. WHAT ARE THE DOCUMENTS REQUIRED FOR BANGLADESH VISA?

- The travel document (passport) to be submitted during the Bangladesh Consulate visa application must not be older than 10 years, torn or worn.
- Passports submitted to the consulate for Bangladesh must be valid 6 months after the start date of the Bangladesh trip. The passport must have at least 2 blank pages for the visa to be processed.

# 3. KNOW BEFORE YOU APPLY TO VISA

- ❑ Applicant must fill-up visa application online using website <https://www.visa.gov.bd/>. Then s/he must bring, in person, to the Consulate the print-out of duly filled-in application with signature on its 3rd page along with necessary documents. However, an authorized person may submit visa application at the Consulate on behalf of the applicant.
- ❑ When applying for a visa, the passport must have validity at least 6 months. At least two blank pages in the passport is required for visa sticker to be pasted.
- ❑ Acceptance of visa application does not necessarily guarantee the grant of a visa. The Consulate may reject any application without citing any reason/explanation thereof. Applicant may be called for an interview if it is felt necessary by the visa issuing officer.
- ❑ The Visa Fee is non-refundable even if the visa is refused. Only bank payment is acceptable.
- ❑ In general, 7 (seven) working days is required for processing visa from the date of submission of application at the Consulate. Some visa applications are subjected to second round of examination that requires additional time to process.

# 5. TOURIST VISA

- A Turkish national or any foreign national who has valid residence permit of Turkey may apply for a tourist visa for the purpose of tourism or reunion with friends & relatives or attending conference/workshop/study tour etc.
- A tourist visa may be issued for maximum 3 (three) months duration with single entry.
- Except the mentioned purposes of the application, no other activity is permissible.



## 6. DOCUMENTS REQUIRED TO BE SUBMITTED FOR TOURIST VISA APPLICATION

- Print-out of duly filled-in and submitted online Visa application form with applicant's signature on 3rd page;
- One (1) recent passport size colour photograph with white background;
- Passport (with at least for six months validity);
- Confirmation of Hotel Booking & Ticket Booking;
- Invitation letter from any Bangladeshi citizen/ organisation;
- Photocopy of previous visa (if any);
- Valid Passport Photocopy/ National ID card of the inviting person;
- Applicant's employment letter (if any);
- Bank statement of the last 3 (three) months of the applicants;
- Turkish residence permit for nationals other than Turkish;
