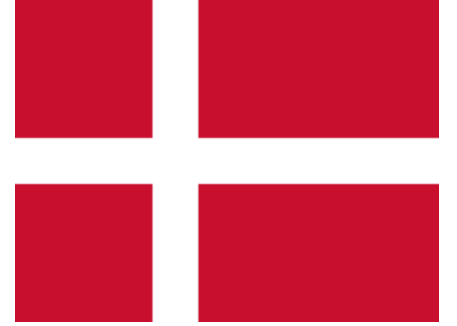

# 1. GENERAL INFORMATION

- Denmark is a member of the European Union, and the majority of its visa policy is based on EU regulations. Citizens of the European Union, the European Economic Area (Norway, Iceland, and Lichtenstein), and Switzerland are eligible for visa-free entry into Denmark. Given that they do not take up employment and their stay is limited to a maximum of 90 days per 180 days.
- Aside from EU, EEA, and Swiss citizens, Denmark has signed numerous bilateral or multilateral agreements with countries from all over the world to mutually abolish visa requirements.
- Their stay is also limited to a maximum of 90 days per 180 days, and they are not permitted to work.

\*Citizens of these countries required to have biometric passports.

\*\*Only holders of passports that include an identity card number.

\*\*\* The rules on travel regarding Brexit will stay the same until 31 December 2020.

*Countries that are not listed above have to apply for a Schengen Visa beforehand to enter Denmark.*

# 2. REQUIRED DOCUMENTS

*You are required to present the following documents if your nationality is not eligible for a visa-free entry to Denmark:*

- Fully completed, printed and signed Denmark visa application form
- Two identical passport-sized photos which are no older than three months
- A passport that is valid for at least three months before the planned date of departure, issued in the last 10 years, and must contain two blank pages
- Copies of previous visas if applicable
- A cover letter that states your purpose of visit
- Round-trip flight ticket information
- A travel insurance that is valid in Denmark and Schengen area as well.
- Hotel booking or accommodation documents covering the duration of stay
- Proof of civil status
- Proof of sufficient income that will cover your expenses during your visit
- Supporting visa sponsorship documents of the sponsor if applicable

*There are additionally required or supporting documents from certain applicants:*

**Student:**

- Proof of enrollment and no objection certificate from the registered school
- Sponsorship documents if the applicant cannot support himself/herself financially during the period of the stay

**Employed:**

- Employment contract
- A letter from the company that states your absence, duration of the stay, and confirms returning to current job
- Bank statement of the last six months
- Income tax return if applicable
- Original bank slips

## *Denmark Visa Requirements for US, UK, and Canada:*

- Citizens of the United States, the United Kingdom, and Canada can enter Denmark without a visa if:
- Their passport is valid for more than three months from the expected time of arrival to Denmark,
- They can present proof of sufficient financial means,
- Purpose of the visit is clear and documented.
