1. GENERAL INFORMATION

- Turkish citizens who will be engaged in touristic activities in the country are exempt from visa.
- Turkish citizens holding special (green) passports, ordinary (burgundy) passports, diplomatic (black and red) passports and service (grey) passports do not require a visa for a period not exceeding 90 days within 180 days, in accordance with the agreement signed between Jordan and Turkey on 1 December 2009.
- However, a visa is required from those who will travel to the country for different purposes.
- Besides Turkey, Jordan also grants visa liberalization to citizens of **Bahrain, Kuwait, Lebanon, Oman, Qatar, Saudi Arabia and the United Arab Emirates** . Citizens of **Egypt, Yemen and Palestine** are *exempt from visa for 30 days* .
- Citizens of 61 countries are subject to visa application at the border. Citizens of these countries can obtain a single-entry visa valid for a maximum of 30 days for a specified fee. [Click](#) for country list .

2. VISA TYPES

Short Term Visa

- Short-term visas are issued for purposes such as touristic trips, business trips and family visits. These visas can be obtained for a maximum of 6 months. Visa fees vary according to the right of entry. Those who will travel to Jordan for a short time can apply for single, double or multiple entry visas. Single-entry visas for 30 or 60 days within 180 days; double entry visas 90 days; Multiple entry visas can be obtained for a maximum of 180 days.

Long Term Visa

- Those who will stay in the country for more than 6 months apply for a long-term visa. Reasons such as residence permit, work, family reunification are considered within a long-term visa.

3. WHAT ARE THE JORDAN VISA APPLICATION REQUIREMENTS?

- The application form, which is prepared with English and Arabic language options, must be filled in completely and without errors. Consulates also require wet signatures on application forms.
- The information in both the application form and other documents to be submitted to the consulate must be consistent with each other.
- Passports to be used in visa application must be valid for 6 months more than the end of the trip and must be for a maximum of 10 years.

4. DOCUMENTS REQUIRED FOR JORDAN VISA APPLICATION

1. A passport or travel document with at minimum two blank pages, valid for at least six months and for at least 90 days after the end of travel. Copy of the first page including personal data and previous visas if obtained.
2. Completed and signed visa application form along with two biometric photo that is not older than 6 months.
3. Proof of travel with confirmed both-way tickets.
4. Bank account details proving that the passenger can sufficiently fund his/her travel.
5. It is important that the applicant does not pose any threat to the public health, security, morals, or the national economy. Hence, the applicant should not be accused or convicted of a crime.
6. Evidence of occupation in the form of certified documents through employer letter, student certificate, document of registration or demonstration of pension funds.
7. Accommodation details through an invitation letter or proof of your hotel reservation throughout your stay.
8. Documentation of travel health insurance that is valid in Jordan throughout the entire period of stay.
 - Specific documents to enclose your application may differ depending on your employment status.

Documentation of University enrollment

No-objection certificate from school management

Employed:

- Employment contract (original certificate of employment indicating the position in the company and the salary)
- Bank account statement of the past 6 months
- Approval letter of leave from employer
- Income Tax Return (ITR)
