1. WHAT IS SCHENGEN VISA?



A Schengen visa is a short-term visa that allows its bearer to travel across the Schengen Area. The Schengen region includes 26 nations ("Schengen States") with no border restrictions. Austria, Belgium, the Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Iceland, Italy, Latvia, Liechtenstein, Lithuania, Luxembourg, Malta, the Netherlands, Norway, Poland, Portugal, Slovakia, Slovenia, Spain, Sweden, and Switzerland are among these nations.

Schengen visa is an authorization granted by a Schengen State to:

- a planned stay in the territory of the Schengen States for no more than 90 days in any 180-day period ("short stay visa")
- a transit via the international transit areas of Schengen airports ("airport transit visa")

2. GENERAL INFORMATION

Citizens of Türkiye required a visa to travel the Republic of Lithuania. You can apply visa to Lithuania from nearest consulates and embassies, also you can apply from VFS Global.

To go to Lithuania, you should get one of the Schengen Visas provided below:

1. Airport transit visa (A) - a visa valid for transit through the international transit areas of one or more airports of the Schengen Member States.
2. Short-stay visa (C) – a visa valid for transit through or an intended stay in the territory of the Schengen Member States of a duration of no more than 90 days in any 180-day period.
3. National visa (D) is issued for a period of at least 91 days. National visa shall be issued to a foreigner whose purpose of entry into the Republic of Lithuania is long term stay. A foreigner holding a national visa (D) may enter the Republic of Lithuania and stay in the country for a period of time specified in the national visa. This period shall not exceed 12 months.

3. TOURIST VISA

Tourist visas are issued to persons who intend to visit Lithuania for tourism and sightseeing but do not have an invitation from a Lithuanian referent.

REQUIREMENTS:

1. Schengen visa application form, completed and signed.

 - An application is to be completed **online** at <https://visa.vrm.lt/epm/>
2. A valid travel document
3. 2 colour photos
4. Proof of adequate travel medical insurance covering the entire period of intended stay
5. Proof of confirmed roundtrip flight ticket or reservation to the country of final destination and to the country of origins or residency, or other proof of intended transport
6. Proof of accommodation for the whole duration of the intended stay (e.g. document from the establishment providing accommodation, proof of private accommodation or any other appropriate document indicating the accommodation envisaged in accordance with the legislation of the Member State concerned)
7. Proof of financial means

8. If the applicant is employed:

- General employment letter. Recent (not older than one week), official and signed original letter from employer (headed letter with name, position of signatory and date of issue, address, recent telephone number and registration number in Turkey) and signed and stamped payslips for the last 3 months;
- The company registration in the chamber of commerce and a copy of the bulletin of the trade register;
- Recent statement of taxes payment;
- Company activity certificate (Faaliyet Belgesi);
- Signed and stamped permission letter issued by the employer.

9. If the applicant is owner of a private company:

- The company registration in the chamber of commerce and a copy of the bulletin of the trade register;

10. If applicant is a retired person

- His/her retirement document and detailed vital record

11. SGK service document (SGK hizmet dökümü) with readable QR code

12. For Turkish nationals, a copy of Identity Card. For non-Turkish nationals, proof of legal residence

13. Copy of passport's first page and Schengen visas received in the last 3 years

14. A letter in English or Turkish written by Applicant, explaining his/her travel

15. For minors:

- Copy of the birth certificate
- Original copy of the notarized permission signed by parents ("Letter of Consent")

VISA FEE LIST	
Ordinary fee (aged 12 years and above)	80 €
Children between 0- 5 years (until the age of 6 years minus one day)	No fee
Children between 6-11 years (until the age of 11 years minus one day)	40 €
Nationals of Albania, Azerbaijan, Bosnia-Herzegovina, Macedonia, Moldova, Montenegro, Russia, Serbia, Ukraine and Georgia	35 €
Spouse and/or Child of EU Citizen	No Fee

Processing Time

Your visa application will be processed in approximately 10 days.

4. NATIONAL VISA

A student entering the Republic of Lithuania to study under a student exchange program drawn up by an international higher school or a higher school registered and operating in the Republic of Lithuania and a foreign higher school.

A completed and signed application form for National visa. An application is to be completed online at <https://visa.vrm.lt/epm>

REQUIREMENTS:

1. A completed and signed application form for National visa
2. A valid travel document
3. 2 colour photos
4. The mediation letter (request to issue a multiple-entry national visa to applicants) of the inviting institution, enterprises or organizations of the Republic of Lithuania, where the applicant comes, submitted in accordance with the established procedure. The Letter of Mediation is submitted electronically via the Information System of Electronic Services (<https://www.migracija.lt/>)

5. Document proving travel medical insurance Travel medical insurance shall cover any expenses, which might arise in connection with repatriation for medical reasons, urgent medical attention and/or emergency hospital treatment or death, during their stay in the Republic of Lithuania. The insurance shall be valid throughout the territory of the Member States and cover the entire period of the person's stay. The minimum coverage shall be EUR 30 000
6. Proof of confirmed roundtrip flight ticket or reservation to the country
7. Original Grant certificate issued by the Turkish National Agency or Turkish university
8. Letter of Admission to the University or College in Lithuania (in English)
9. Student certificate issued by the Council of Higher Education in Turkey (YÖK) with readable QR code
10. Proof of accommodation for the whole duration of the intended stay (e.g. document from the establishment providing accommodation, proof of private accommodation or any other appropriate document indicating the accommodation envisaged in accordance with the legislation of the Member State concerned)
11. Proof of financial adequacy

12. SGK service document (SGK Hizmet Dökümü) with readable QR code.
13. Criminal Record in Turkish with readable QR code
14. For Turkish nationals, a copy of Identity Card. For non-Turkish nationals, proof of legal residence
15. Copy of passport's first page and all pages containing stamps or visas are required

You can make an application online at EPM

EPM is the online Visa Application Form of the Republic of Lithuania which is designed to complete and submit the Application for a Schengen or National visa to the consular services of the Republic of Lithuania.

6. GENERAL APPLICATION REQUIREMENTS

To finish the application procedure for a short-stay visa to Lithuania, you must do the following:

Determine which visa type is appropriate for your purpose of entrance.

Determine where you want to apply.

- Fill out the short-stay visa application form for Lithuania
- Gather information about the Lithuanian visa requirements
- Make a visa interview appointment
- Attend the interview in the Lithuanian Embassy/Consulate/VAC of your choice

Steps of Application:

1. Identify your visa type
2. Prepare your documents
3. Book an appointment
4. Visit a visa application center
5. Track your application
6. Collect your passport

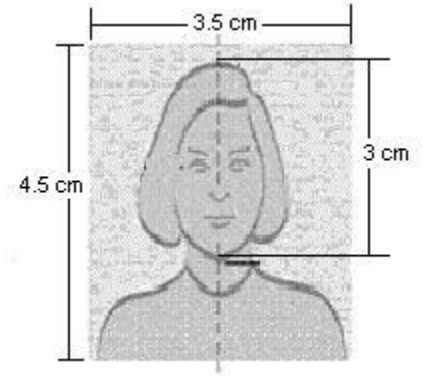
DOCUMENTS:

1. Lithuanian visa application form
2. Two passport photos
3. Copies of your previous visas (if applicable)
4. Your valid passport
5. Lithuania Travel Health Insurance
6. Proof of means of transport
7. Proof of accommodation
8. Proof of sufficient financial means for the period of stay in Lithuania
9. A cover letter
10. Proof of civil status

PHOTO SPECIFICATIONS:

- Actual (created within the last 6 months), size 3.5 x 4.5 cm, printed on picture paper
- The face must occupy 70-80% of the area, and the face from the chin to the upper head must occupy 31-36 mm
- The background is white and black and white
- The person in the photograph must not be wearing sunglasses
- Except for religious headwear, the individual in the photograph must be devoid of headwear or other items that cover the head
- The lenses of glasses cannot be darkened
- There can be no lighting effect in the image
- Eyewear should not obscure vision
- In the image, the mouth must be entirely closed
