1. GENERAL INFORMATION

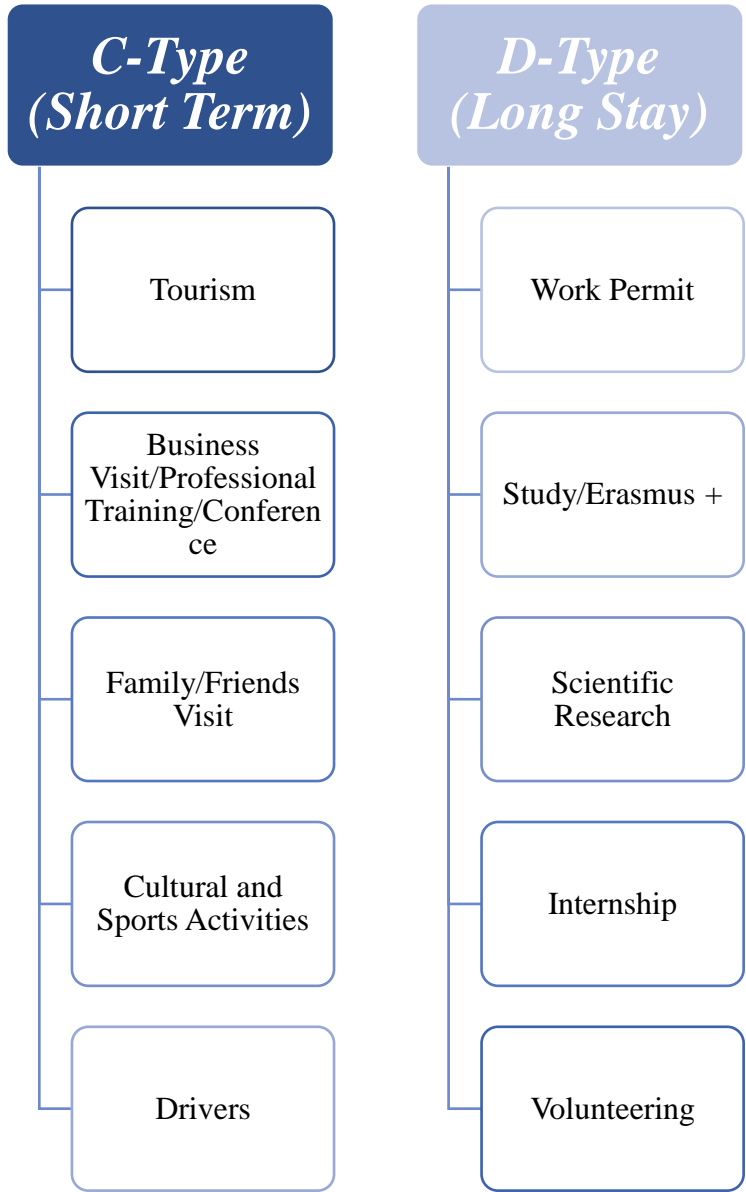
- Poland is one of the countries that offer visa conditional entry. You can apply for a visa from VFS global or at the [nearest consulates](#).
- There are two types of visas available for entry into Poland: Type C and Type D.

What exactly is a C-type visa?

The Uniform Schengen Visa is valid across the Schengen Area and allows its bearer to stay in the territory of all Schengen Area Member Countries for up to 90 days in a 180-day period.

What exactly is a D-type national visa?

A D-type national visa allows you to enter the Republic of Poland's territory and stay continuously or several times for a total duration of more than 90 days within the visa's validity period, but not more than one year.



2. VISA EXEMPTION

- Turkish Holders of special passports are exempt from the visa procedure for a period not exceeding 90 days in Poland.

The following applicants are exempt from paying the visa fee:

Children under the age of six, as determined by a decision of the European Parliament on 13 July 2009; those traveling to Poland for educational purposes; researchers traveling from third-world countries for scientific research, whose short-term visa regimes will be facilitated by Schengen area countries in accordance with a decision of the European Parliament and the Council on 28 September 2005, as determined by decision no. 810/2009; seminars, sports, and cultural activities organized by non-profit organizations.

4. STANDARD VISITOR VISA (TOURISM)

This type of visa counts on C-Type Visa

Requirements:

- 1-** Visa filled in online or by hand through the e-konsulat system and printed and signed application form
- 2-** 3.5 x 4.5 cm color passport photo
- 3-** Photocopy of passport and passport pages
- 4-** Travel health insurance with a minimum coverage of 30,000 Euros and valid in all Schengen countries
- 5-** Full Documented Identity Registration Example
- 6-** That the region of your residence is within the jurisdiction of the consulate where the visa application is made
Residence and Other Address Document showing

*Citizens of other countries other than Turkey can also leave the territory of the Member States. Proof of Residence Permit valid for three more months after the planned departure date needed.

7- Income certificate

8- Another document proving the flight reservation or planned means of transportation or travel document that proves its route

9- Accommodation document (e.g. official invitation or hotel reservation)

10- Document confirming the purpose and conditions of stay

11- Notarized statement from parents for minors traveling alone

In case of consent or only one of the parents: Written consent from other parent/guardian is required (original and photocopy)

! Important Note: Depending on the application, additional documents may be requested according to the details requested.

5. STUDENT VISA (Erasmus+)

D-Type visas include student visas.

Requirements:

- 1- National visa form, carefully completed, legible, and signed
- 2- A passport that satisfies the requirements
- 3- 1 biometric photo that passes the requirements
- 4- Health insurance with a minimum coverage of €30,000 for each scheduled day of stay
- 5- A certificate of acceptance from the educational institution or proof that the education is ongoing
- 6- In the case of Erasmus education, official confirmation from the sending university that the student has been admitted to the program
- 7- Confirmation of payment (If the training is compensated)
- 8- Confirming that it has sufficient financial resources to meet the expenditures required
documentation: return expenses, living expenses, living costs

- 9- The diploma from the most recent school.
- 10- Years of Polish or foreign language competency at the standard education or Erasmus education certificate level.
- 11- Criminal records.
- 12- Military Status Certificate (above 35 years old) or proof of current student status in Turkey (save for those presenting a student certificate).
- 13- Non-Turkish citizens: A residence permit is valid till the date of departure from Turkey to Poland.
- 14- With the page containing the personal data in the passport, Poland or other Schengen issued in the previous 3 years
Photocopies of visas of their countries. Visa application fee of \$15 (non-refundable even if the visa is refused).

! Important Note: The requested documentation must be current (max. 3 months old). The applicant must produce both the original papers and their duplicates. The Consul may seek more papers.

6. APPLICATION REQUIREMENTS

Requirements For General Application:

1. **Valid Passport:** The passport must be valid for at least three months after the scheduled return date from Poland.
2. **Travel Medical Insurance:** Medical insurance with a minimum coverage of € 30,000 that is valid in all Schengen countries (original and copy). If you apply for a single-entry visa, the insurance coverage should cover the whole time of validity of the visa as well as all specified days of stay.
3. **Minors:** Traveling alone or with one parent as a minor (under 18) requires the approval of the other parent or legal guardian (original and photocopy).
4. **Evidence of Sufficient Financial Resources:** The quantity of financial means that a foreigner must take with them while entering the Republic of Poland, as well as the sort of documentation that certify ownership of the financial means and specify the purpose of entry.
5. **Biometrics:** Individuals applying for a Schengen visa will be obliged to furnish biometric data since the implementation of the VIS (Visa Information System) (fingerprints and a digital photograph).

A photograph submitted with a visa application must meet the following requirements:

- It must be a recent photograph (dated max 6 months old)
- A colored photograph printed on regular photographic paper is required
- The passport photo must be 35 x 45 mm in size (width x height)
- Width: between 16 and 20 mm from ear to ear
- Height: from age 11: between 26 and 30 mm from chin to crown
- Up to the age of 11: between 19 and 30 mm from chin to crown
- Straight forward whole face 30 mm from the tip of the chin to the top of the hair
- Photographed against a white background
- Without sunglasses
- Unless you wear a hat or other head covering for religious reasons
- Toned or reflective glasses should not be worn with spectacles
- The eyeglass frame may not completely cover the eyes

VISA FEE Only Ukranian citizens are exempt from paying	78 USD (Please provide exact amount in cash)
6-12 AGED CHILDREN (NOT OVER 12)	46 USD
VFS SERVICE FEE	12,00 Euro (** to be paid in TL as per daily Exchange rate)
