1. GENERAL INFORMATION

Do I need a visa to go to Thailand?

Turkish people are allowed to travel Thailand without visa until 30 days. Also, the people from turkey could not apply visa from Thai E-Visa system. You should apply for a visa in person at the nearest Thai Embassy or Consulate.

2. VISA EXEMPTION

For a Visit of Up to 30 Days; Passport holders from some countries/territories, **down the link**, are exempt from needing a visa to enter Thailand for tourism and will be allowed to travel in the Kingdom for a period of up to 30 days on each visit. In Türkiye also exempted to visit up to 30 days.

- ! • Travellers entering Thailand under the Tourist Visa Exemption Scheme must possess adequate cash of or equivalent to 20,000 Baht per person or 40,000 Baht per family.
- ! • Entering the Kingdom through land/sea border checkpoints under Tourist Visa Exemption Scheme is permitted only twice in a calendar year, except nationals of Malaysia, Brunei Darussalam, Indonesia and Singapore who may enter Thailand through such checkpoints more than twice in a calendar year.

3. TOURIST VISA (For tourism, short visit or medical)

Ordinary passport holders who desire to enter the Kingdom of Thailand for the following reasons must get a Tourist visa:

- Tourism
- A quick trip to Thailand to see family
- Medical treatment in licensed hospitals
- Participants at TCEB-sponsored MICE (Meetings, Incentives, Conventions, and Exhibitions)

Number of Entry	Visa Validity	Period of Stay	Visa Fee
Single Entry	3 months	60 days	40 USD
Multiple Entry (METV)	6 months	60 days / each entry	200 USD

Required Documents:

(Please check the local embassy/website consulates for specific necessary documents)

1. A passport or travel document valid for at least six months
2. A photograph of the applicant that was taken within the last six months
3. Evidence of Thailand trip (air ticket paid in full)
4. Proof of enough funding (20,000 Baht per person and 40,000 Baht per family)

4. NON-IMMIGRANT (For foreigners who wish to study in Thailand)

Ordinary passport holders whose sole purpose of visit is to study in Thailand are eligible for a Non-Immigrant ED Visa.

Required Documents:

1- Higher education level studies (university and college)

! **Important Note:** Please check the local embassy/website consulates for specific necessary documents) o Study at the elementary level (primary, elementary, and secondary school)

- A passport or travel document valid for at least six months. Photograph taken within the last six months of the applicant
- A letter from the school verifying enrolment data, signed by an authorized person, and accompanied by a copy of the signer's ID card or passport
- The registration certificate from the university
- An academic certificate from a previous level of schooling

2- Internship (Curricular internship), participation in a workshop training or seminar sponsored by an international organization

- A passport or travel document valid for at least six months
- A photograph of the applicant that was taken within the last six months
- A letter from the company/international organization verifying the internship/participation in a program
- A letter from the visa applicant's university/educational establishment verifying the curricular internship

Number of Entry	Visa Validity	Period of Stay	Visa Fee
Single Entry	3 months	90 days	80 USD

5. TRANSIT VISA

Ordinary passport holders who desire to enter the Kingdom for the following reasons must get a Transit visa:

- Travel through the Kingdom in transit to the country of destination or to re-enter his/her own country
- Participate in sports for no more than one month (sportsmen, sportswomen)
- Person in charge or crew of a conveyance arriving in the Kingdom at a port, station, or region
- Valid for three months.
- Travelers arriving in Thailand with a transit visa will be allowed to stay for a maximum of 30 days.

! **Important Note:** It is recommended that visa applicants submit their applications at least 15 working days before their desired travel date to Thailand.

Required Documents:

1. A passport or travel document valid for at least six months
2. A photograph of the applicant that was taken within the last six months
3. Evidence of Thailand trip (confirmed air ticket paid in full)
4. Proof of enough funding (10,000 Baht per person and 20,000 Baht per family)
5. A third-country visa in a passport or travel document
6. Invitation/acceptance letter confirming the applicant's participation in sports/training activities in the Kingdom (If participating in sports/training activities)
