# 1. GENERAL INFORMATION

Getting a visa to Romania can be done by going to the nearest consulates or by starting the application from the online E-visa application website.

There have 4 types of visa to Romania:

1. The airport transit visa (marked A)
2. The transit visa (marked B)
3. The short-stay visa (marked C)
4. The long-stay visa (marked D)

## 2. SHORT-STAY VISA (MARKED C)

- It permits foreigners to request access to Romanian territory for reasons other than immigration, for an unbroken stay or repeated stays of no more than 90 days during any period of 180 days preceding each day of stay on Romanian territory. This type of visa might have one or more entries.
- The right of residence of a short-stay visa holder cannot be extended.
- Short-term visas are issued based on the purpose of the journey to Romania. Romania issues the following sorts of short-stay visas: Official mission, Tourism, Private visit, Business, Transport, Sports activities, The carrying out of cultural, scientific, humanitarian activities, short-term medical treatment or other activities that do not contravene Romanian laws.

### 3. TOURISM (MARKED C/TU)

**Given the previously selected conditions, Turkish nationals will require a visa to enter Romania.**

**However, if you fall into one of the following categories, you are exempt from the Romanian visa requirement for stays of no more than 90 days in any 180-day period:**

- I hold a two or multiple entry short-stay visa issued by a Schengen member state
- I hold a limited territorial validity visa issued by a Schengen member state
- I hold a short-stay visa issued by Bulgaria, Cyprus or Croatia
- I hold a long-stay visa issued by a Schengen member state; Bulgaria, Cyprus or Croatia
- I hold a residence permit issued by a Schengen member state; Bulgaria, Cyprus or Croatia
- I hold a long-term resident's EC residence permit (the validity of which is of 5 years or more) issued by a member state of the European Union

## ***REQUIRED DOCUMENTS:***

1. Vehicle supporting documents (Valid driver's license, Green card «International Motor Insurance Card», and registration documents of the means of transport for vehicle drivers.)
2. [\*Application form\*](#)
3. Travel medical insurance that covers of at least €30,000 regarding medical emergencies
4. Valid passport
5. Accommodation
6. Photographs (Two recent 3x4 cm, coloured photographs)
7. Travel ticket
8. Proof of sufficient financial means set by the ministry
9. Proof of itinerary

## 4. THE LONG-STAY VISA FOR STUDIES (MARKED D/SD)

The national long-stay visa permits foreigners to enter and stay on Romanian territory for up to 90 days.

It enables foreigners who have entered Romanian territory to apply to the Ministry of Administration and Interior - General Inspectorate for Immigration to prolong their temporary stay and get a residency permit. The extension of the right of stay in Romania must be requested at least 30 days before the validity of the long-stay visa expires.

### ***REQUIREMENTS:***

1. Two recent 3 x 4 cm, coloured photographs
2. A valid travel document accepted by Romania, on which a visa can be affixed. The validity of the travel document must exceed the validity of the visa you apply for, by at least 3 months, and must have been issued no later than 10 years ago
3. Proof of acceptance for studies: Evidence of acceptance for studies from the Romanian Ministry of Education, attesting that the visa application will study full-time at a state or private higher education institution that is accredited or conditionally recognized under Romanian law
4. Proof of payment

6. Means of support: Evidence of financial support at the level of the monthly minimum promised gross salary for the duration of the visa
7. Criminal record
8. Travel medical insurance
9. Consent of the legal representative
10. Proof of accommodation
11. Evidence of knowledge of the language of the academic program to be followed, with the exception of the Romanian language preparatory year for foreign residents
12. Birth certificate, in copy and notarized translation

## 5. AIRPORT TRANSIT VISA (MARKED A)



### *What exactly is a Romania Transit Visa?*

It enables entry into the international airport zone and parking until the plane departs for the destination country.

### *Do I Need an Airport Transit Visa?*

The nationals of the following countries need an airport transit visa when passing through the international transit area of Romania Airports : Afghanistan, Bangladesh, Democratic Republic of the Congo, Eritrea, Ethiopia, Ghana, Iran, Iraq, Nigeria, Pakistan, Syria, Somalia, Sri Lanka.

! **Important Note:** There are some exceptions to the obligation to hold an airport transit visa. To see those exceptions please [click here](#).

! **Important Note:** You should have a documentation regarding the continuation of the journey to the final destination after the expected airport transit, information that facilitates the assessment of the applicant's intention not to enter the territory of the member states.

## 7. VISA FEES

In accordance with the provisions of the legislation in force, visa processing fees are as follows:

TYPE OF VISA	CONSULAR FEE
Airport transit (marked A)	80 EUR
Transit (marked B)	80 EUR
Short stay (marked C)	80 EUR
Type A, B, C visas, issued to children aged between 6 and 12 years	40 EUR
Long stay (marked D)	120 EUR

! **Important Note:** The visa processing fees are charged in EUR, as well as in US Dollars, or in the currency of the state of residence, based on the average exchange rate from the previous month. In countries with a free currency market, visa fees are usually charged in EUR or in US Dollars.
