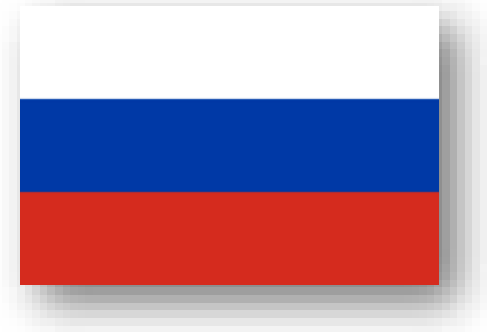

1. GENERAL INFORMATION

Do I need a visa to go to Russia?

Unless specifically allowed by an international agreement, a foreign citizen or stateless person need a visa to enter the Russian Federation. Turkiye applicants require a visa to enter Russia.

Where to apply visa to Russia?

Russian visas are obtained at the nearest Russian embassy or consulate. An official invitation processed by Russian administration or officially sanctioned companies is required to obtain a visa.

! *Important note:*

- Regardless of the number of visas obtained, a foreign citizen's total term of stay on Russian Federation territory may not exceed 90 days in any 180-day period. This provision does not apply to visitors on employment or study visas.
- Russian consulate offices grant visas based on the purpose of the travel and the length of the foreigner's stay on Russian Federation territory.

2. TOURIST VISA

Foreign citizens who wish to visit the country for the purpose of tourism are granted a regular tourist visa (attending cultural events, excursions, sightseeing). You can receive an ordinary tourist visa based on a confirmation from a tour operator included in the unified federal registry, or by reserving a hotel room included in the federal list of hotels.

A single-entry tourist visa can be issued for up to three months, while multiple entry visas can be issued for up to six months.

REQUIREMENTS:

1. The original confirmation and tourist voucher issued by the tour operator, which is registered in the unified register of tour operators
2. Booking a hotel and a plane ticket
3. Original passport containing at least 2 blank visa pages, valid for 6 months after the visa expires

4. An online visa application form filled out on the <https://visa.kdmid.ru/> website, printed out and signed personally by the applicant
5. A photograph
6. Insurance is a mandatory document for citizens of Iran, Israel, Ireland, the Schengen countries, and China
7. Persons who are not Turkish citizens must provide an original and a copy of a residence permit in Turkiye, valid for at least 3 months from the date of visa application

3. STUDY VISA

A standard study visa is issued to citizens of Turkiye and citizens of other states entering the Russian Federation for the purpose of studying at an educational institution, based on an invitation issued by the Main Directorate for Migration of the Ministry of Internal Affairs of Russia and subdivisions for migration issues of the territorial bodies of the Ministry of Internal Affairs of Russia or the Ministry of Foreign Affairs of the Russian Federation.

REQUIRED DOCUMENTS

1. An invitation from the Russian Federation's Ministry of Foreign Affairs or an eligible General Directorate for Migration for Russia's Ministry of Internal Affairs

! **Important Note:** If you are applying through the Visa Application Center in Istanbul, the invitation (TELEX) must be sent one day before applying for a visa for verification from the General Consulate.

2. An original passport containing at least 2 blank visa pages, valid for at least 1.5 years from the start date of visa validity
3. Online application form completed on the website visa.kdmid.ru, printed and signed in person by the applicant
4. A photograph
5. Insurance is mandatory for citizens of Iran, Israel, Ireland, the EU and China
6. HIV certificate getting on the territory of Turkiye and issued not earlier than 3 months before the date of submission of documents with signature and stamp of the clinic specialist

! **Important Note:** If you are not a Turkish citizen, you must apply for a residency visa that is valid for at least three months. Before awarding a visa, the Embassy/Consulate may request further papers, invite you to an interview, or extend the period required for consideration of your visa application. Please contact the Russian Visa Application Centre for more information on the visa process for nationals of your country.

4. TRANSIT VISA



Do I Need an Airport Transit Visa?

Turkish nationals and foreign people traveling to another country via the Russian Federation are granted transit visas. Transit visas are valid for up to ten days if traveling by vehicle and three days if traveling by plane. To obtain a visa, you must give a copy of your trip tickets along with a valid visa or passport of the country of destination.

Required Documents:

- Valid tickets for entry
- Entrance visa for the country after the Russian Federation, or visa for the final destination, or passport for the final destination
- Original passport containing at least 2 blank visa pages, valid for 6 months after the visa expires
- Photograph

- An online visa application form filled out on the website visa.kdmid.ru, printed out and signed personally by the applicant
- Insurance is a mandatory document for citizens of Iran, China, the United States and citizens of the European Union
- Persons who are not Turkish citizens must provide an original and a copy of a residence permit in Turkiye, valid for at least 3 months from the date of visa application

! ***Important Note:*** When filling out the application form, please indicate the Visa Application Center of the city where you are going to apply for a visa.

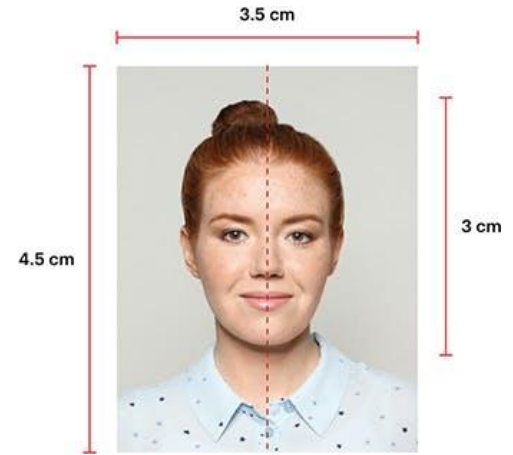

6. PHOTO SPECIFICATIONS

Please provide two recent photographs not more than 6 months old.

The Photographs Should Have:

- 3,5 x 4,5 cm photograph taken against a light background (white or off-white) to distinguish details and contrast against the background
- Has good clarity and focus on the face
- Camera print on standard photographic paper
- Full-face, non-smiling (no sunglasses, hats/caps, or other head coverings, unless the applicant wears such items due to religious beliefs or ethnic origin)



7. RUSSIAN E-VISA SYSTEM

What is Russian E-visa?

It is a document that allows tourists from many nations to visit various regions of Russia. The majority of foreign people who desire to visit the Russian Federation must apply for a visa, albeit the type of travel document necessary will vary depending on nationality, as well as the purpose and duration of the visit.

Visitors can apply for their Russian visa totally online in minutes from anywhere in the world using eVisas. Passport copies, online application forms, and other visa-related paperwork can be submitted online.
