1. GENERAL INFORMATION

Some countries are exempt from Visa for certain days. Turkish passport holders do not require a visa to enter Brazil and are granted permission to stay for up to 90 days when arriving.

For long-term stays or to live and/or work in Brazil, all foreign nationals (including those from visa waiver countries) must apply for the resident permit at a Brazilian embassy.

On connecting flights, check whether the nation or countries to be transited through require a transit visa. It is strongly advised to obtain further information from the local Consulate.

2. VISA EXEMPTION

- Some nations and nationalities are permitted to visit Brazil for up to 30, 60, or 90 days without obtaining a visa.
- If you want to remain longer than the day period for which you are visa-exempt, please contact your consulate for more information.
- Turkiye citizens do not need a visa to travel as tourists for up to 90 days in a year.

3. VISITOR VISA (VIVIS)

- Visitor Visa are issued for purposes such as tourism, business, transit, artistic or sporting activities, study (short courses), volunteer work, or attendance at conferences, seminars, or meetings, among others.
- The visitor visa *allows for a stay in Brazil of up to 90 days*.
- Turkish citizens do not need a Visitor Visa to travel to Brazil and stay for up to 90 days for the purposes listed above. Once in Brazil, you may apply to the Federal Police for an extension of this period, if your stay does not exceed 180 days in a year.

REQUIREMENTS:

1. *Electronic visa application form*
2. Receipt of the Visa Request Form (RER), obtained at the end of the electronic visa application form. The receipt must be printed, signed (by the applicant or, in the case of minors, by both parents), and a photo must be attached to the appropriate box.
3. Valid passport with at least two (2) blank pages
4. Round trip ticket reservation
5. Hotel or other accommodation reservation
6. Bank account statements for the last 3 months
7. Declaration of employment or study in Turkiye (a letter from the employer or from the University, for example)
8. Visa fee payment receipt

4. STUDY VISA (VITEM IV)

- A student visa is required for foreign nationals traveling to Brazil to participate in regular courses or academic internships.
- If these activities will last less than 90 days, the applicant must apply for a visitor visa.
- Primary and secondary education, undergraduate and postgraduate degrees, technical courses, and language courses are examples of regular courses. For declarations to be accepted, courses must be legally registered with the Brazilian Ministry of Education.
- Applicants interested in academic internships in Brazil must be affiliated with an education institution outside of Brazil, and the internship must include activities that will improve their academic or professional qualifications.
- A minimum weekly workload of 15 hours is required for a Student Visa and must be clearly stated in the documents presented to the consular agent.
- Foreign nationals who are in Brazil may apply for a residence permit for the purposes of study.

- The Student Visa grants the applicant permission to study at a specific institution. Before applying for a university transfer, the student must first contact the Federal Police.
- Student visas have a maximum validity term of one year. Once in Brazil, the student must apply to the Federal Police for a residency permit within 90 days of arrival. Failure to do so will result in the revocation of the visa.

REQUIREMENTS:

2. Receipt of the Visa Request Form (RER), obtained at the end of the electronic visa application form. The receipt must be printed, signed (by the applicant or, in the case of minors, by both parents), and a photo must be attached to it.

3. Valid passport with at least two blank pages
4. Criminal record issued by the applicant's country of nationality (for applicants aged 18 years old or older)
5. Letter from the institution in Brazil that will host the student specifying the name of the course or internship program, duration, period, and weekly workload. The letter must be legalized by a notary public in Brazil (documents issued by public institutions are exempted)
6. Proof of financial means compatible with the entire period of stay in Brazil (i.e., bank or credit card statements, savings certificate, letter from employer etc.) or proof of a scholarship grant
7. Depending on the type of course, additional documents may be required
8. Visa fee payment receipt (Fees may vary according to the nationality)

The fee for a Visitor Visa by nationality:

- For Angola USD 180
- For Algeria USD 85
- For China USD 115
- For all other countries USD 80

Study Visa (VITEM IV) Fee by nationality:

- For United Kingdom USD 465
- For United States USD 160
- For All other nationalities USD 100
