1. GENERAL INFORMATION

Guatemala visa is not required for citizens of Turkiye for a stay up to 90 days. To see other countries that are exempt from visa to go to Guatemala, please [click here](#).

The duration of a Guatemala visa is three months. If you apply for a Guatemala temporary residence permit, you are allowed to stay in Guatemala up to two years.

- **A short-stay Guatemala visa is issued for different purposes, such as:** Tourism, visits, business meetings, health controls etc.
- **A temporary residence permit is issued for different purposes, such as:** Work, study, business/investment, family reunion, retirement. If you are a foreign citizen looking to retire in Guatemala, you can apply for a Guatemala retirement visa.

2. SHORT-STAY VISA

The short stay visa allows *90-days to stay in the country*. Some nations could visit Guatemala without having a visa for three months. This visa is obtained for tourism, visit, health check and similar purposes.

Here are all the steps you need to follow to apply for a Guatemala visa:

1. Book a visa appointment at the nearest embassy/consulate of Guatemala.
2. Gather and submit the requested documents at the embassy/consulate of Guatemala. Consulates may require other documentation depends on the case.
3. After fulfilling all the requested steps, applicant should wait for a response from the embassy/consulate of Guatemala.

3. TEMPORARY RESIDENCE PERMIT (Visa for Stay Beyond 90-Days)

- If you are visiting the country for *more than 90 days*, authorities require a *Temporary Residence Permit Visa*. It is highly recommended to obtain the accurate information by visiting the local consulate or contact them.
- If you wish to *stay beyond the 90-day* residency visa, you can apply for a *six-month* Ordinary Residency (Visa Ordinaria), which must be done before the 90-day visa expires. In Turkiye, the applicant could go Guatemala Visa-free for 90 days, but after a 90-day period before visa exemption ends; the applicant must have a temporary residence permit.
- There are also a visa for students. *Student visas* (For elementary school, high school, and/or university students) are valid for *one year*. The applicant should obtain nearest consulate to apply and take information.

4. GENERAL REQUIREMENTS

The following documentation must be gathered in order to apply for a Guatemala Visa at the closest embassy or consulate:

1. Valid passport (must be valid for at least 6 months)
2. [Application form](#)
3. Valid visa or residence
4. Air ticket or flight itinerary
5. Invitation or employment letter
6. Accommodation proof
7. Valid travel health insurance

8. A cover letter explaining the purpose of your visit to Guatemala
9. A criminal record document
10. Bank statement
11. Two passport-size colour photographs

Important Note: Visa fees for Guatemalan visas, simple visa and tourist or traveler visa US \$50.00; for one entry multiple tourist or traveler visa US \$ 150.00 for multiple entries (valid for 90 days); special guest visa US \$ 50.00 for multiple entries (valid for 180 days)

Important Note: The requirements may change depend on your nation. Some countries require other documentation according to local legislation. It is highly recommended to you to get information from nearest consulates.
