1. GENERAL INFORMATION

Do I need a Visa to go Macedonia?

For Turkish citizens, entry visa to Macedonia is not required for up to 90-days.

Where Can I Apply for a Macedonian Visa?

You can apply for a visa to Macedonia at a local Consulate or Embassy. Before submitting your application, it is best to obtain information on required documents and fees by calling the Consulate's phone number or sending an email.

Visa Application Procedures:

The foreigner applies for a visa to Macedonia's official (resident or non-resident) diplomatic-consular representative no later than six months and at least 15 days before the proposed travel. The visa application must be submitted in person.

! **Important Note:** Nationals of EU Member States and Schengen Agreement signatories do not require a visa to enter the Republic of North Macedonia (and may enter the Republic of North Macedonia with a valid national identity card). These countries citizens may stay no longer than 15 days upon every entry into the territory of the Republic of North Macedonia as long as the total length of stay does not exceed 90 days in any 180-day period.

! **Important Note:** Third-country nationals with multiple-entry Schengen visa (type C) valid for at least 5 (five) days beyond the intended stay in Macedonia may stay no longer than 15 days upon every entry into the territory of Macedonia as long as the total length of stay does not exceed 90 days in any 180-day period.

2. TYPES OF ENTRY VISAS

Airport Transit Visa ('A' visa)

Short-Stay and Transit Visa ('C' visa)

3. SHORT-STAY ('C' VISA) AND TRANSIT VISA ('A' VISA)

Short stay Visa ensure a stay of a foreigner with or without a visa in duration of no more than 90 day within any 180-day period, referring to such a period preceding each day of stay, unless otherwise determined by law or a ratified international agreement.

Required Documents:

1. Travel document *valid at least 3 months* beyond the period of intended stay in Macedonia
2. Travel insurance documents
3. Notarized warranty letter, invitation letter by a Macedonian natural/legal person
4. Proof of possession of sufficient resources for the duration of the stay in Macedonia
5. Photograph (Size 3.5 x 4.5 cm) in color with white background where the face of the applicant is clearly visible
6. Proof of paid fees for processing the visa application
7. Neatly and legibly filled out visa application

4. LONG-STAY VISA ('D' VISA)

Even if countries are exempt from visa requirements for a short-term period, to stay longer in North Macedonia, there would be more need to apply for a long-stay visa by making an application at a local consulate before coming to North Macedonia. *The duration of stay is 180 days maximum within 1 year* in North Macedonia with a long-term (D) visa.

The long-term visa grants entry to Macedonia *based on applying for a residence permit*. It enables one to enter Macedonia as a potential resident and stay while applying for residency. After receiving a decision from the Ministry of Interior granting temporary residence, the applicant must submit the documents corresponding to the visa type.

Temporary residence is granted to a foreigner who intends to stay in the Republic of Macedonia for the following reasons:

Work, study, participation in international student exchange programs, specialization, vocational training and practical training, volunteering, scientific-research activities, medical treatment, accommodation in nursing homes, family reunion.

! **Important Note:** The documents required to stay in Macedonia may vary depending on the circumstances surrounding your stay. Make sure to gather all general requirements before applying, and most importantly, it is highly recommended to obtain information about other application requirements from the nearest consulate.

5. GENERAL REQUIRED DOCUMENTS

1. Valid travel document (the validity period of the travel document must be at least three months longer than the validity period of the visa), the *travel document must have been issued within the last 10 years*, and it must include at least two blank pages for visa purposes and one 35x45 mm photograph.
2. Proof of travel medical insurance for the entire duration of his stay in Macedonia
3. Proof of fees are paid
4. Proof of the purpose of the visit
5. Proof of secured accommodation
6. Proof of means of subsistence to cover the stay in Macedonia and the repatriation or the travel to a third country (The letter of guarantee and the invitation letter by a legal entity must be certified by a notary public)
7. Means of transport and the intention to return to the country of origin or the intention to travel to a third country

There are additionally required or supporting documents from certain applicants:

If employed:

- Proof of employment such as work contract if applicable
- Bank statement of the last six months

If student:

- Proof of enrollment and no objection certificate from the registered school
- Sponsorship documents if the applicant cannot support himself/herself financially during the period of the stay
