1. GENERAL INFORMATION

- Diplomatic, Service, Private, and Public Passport holders are exempt from visa requirements for tourism activities of up to 90 days.

Considerations in Entering and Exiting Money from Tunisia:

- When entering Tunisia, there is an obligation to declare foreign currency assets that amount to *more than 5000 Tunisian Dinars* (approximately 1533 Dollars, 1450 Euros). It is important that the brought foreign currency is only exchanged at banks or other authorized institutions. The expulsion of the Tunisian Dinar from the country is still prohibited.

Time Difference:

- Summertime is not applied in Tunisia and Tunisia is 2 hours behind Turkiye.

Non-Residents:

- Turkish citizens going to Tunisia are required to make their hotel reservations and pay the reservation fees. It is necessary to carry an amount of **50 Euros per day**, equal to the number of days you will stay in Tunisia per person (for example, 350 Euros for someone who will stay for 7 days) and a return flight ticket must be purchased in advance.

Criminal Sanctions:

- In particular, the current foreign exchange legislation and the related penal sanctions are severe. Excess foreign currency amounting to more than 5000 Tunisian Dinars, which is not declared upon entry into the country, is confiscated upon exit from the country, criminal investigations are initiated, entry into the country may be banned and, in some cases, a substantial fine may be imposed.

2. VISA EXEMPTION

Countries that can visit Tunisia for a limited time without requiring a visa include:

Algeria, Andorra, Antigua, Argentina, Austria, Bahrain, Barbados, Belgium, Bermuda, Bosnia and Herzegovina, Brazil, Brunei, Bulgaria, Canada, Chili, Croatia, Commonwealth of Dominica, Denmark, Fiji, Finland, France, Gambia, Greece, Guinea, Germany, Honduras, Hong Kong, Hungary, Ivory Coast, Ireland, Iceland, Italy, Japan, The Republic of Kiribati, Libya, Lichtenstein, Luxembourg, Malaysia, the Maldives, Mali, Morocco, Mauritius, Mauritania, Monaco, Montenegro, Niger, Norway, the Netherlands, Netherlands Antilles, Poland, Portugal, Qatar, Romania, Saint Kitts and Nevis, Saint Lucie, Salmon Island, Senegal, Serbia, The Republic of Seychelles, Slovenia, Sweden, The Sultanate of Oman, Switzerland, South Korea, Spain, *Turkiye*, United Arab Emirates, United States of America, United Kingdom.

3. VISA APPLICATION FROM TURKEY

- Diplomatic, service, private, and public passport holders are exempt from visa requirements for tourist trips of up to 90 days.
- Visa may be required for applications exceeding 90 days. For this, it is highly requested to apply to the consulates and get the most accurate information about long stay.

! **Important Note:** *When applying for a Tunisia visa*, the information you write in the form must be correct and complete so that the Consulates can get detailed information about the visa applicant. In addition, *Visa application forms* must be written and signed in a legible, ballpoint pen when filling out. If you fill out the form in Turkish for the information you have written, there will be no harm in using Turkish characters.

- As a result of visa exemption agreements, Turkish citizens do not need to attend Tunisia visa *procedures such as Tunisia visa, Tunisia visa procedures, Tunisia visa application form , documents required for Tunisia visa , Tunisia visa fee* . But there may have some required documents to get into the Tunisia. To get information about those documentation, please contact nearest consulate.
- *Tunisia visa exemption* is an application that is valid for short-term *Tunisia visas* . If your Tunisia trip does not have a short-term travel content, an application should be made to the Tunisian Consulate in Istanbul or the Tunisian Embassy in Ankara.
