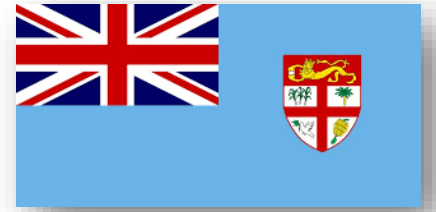

1. GENERAL INFORMATION

The visa applications can be directly lodged at any Fijian Immigration Department office located in Suva, Nadi, Lautoka, Savusavu, Levuka, Labasa and Rotuma or through the nearest Fiji High Commission and Embassy offices stationed abroad.

In Turkiye; ordinary, service, special and diplomatic passport holders are *exempt from visa for 90 days* during their trips to Fiji.

Citizens of another country can learn about visa requirements and visa-free travel opportunities by contacting the relevant consulates before applying for a visa.

3. GENERAL REQUIREMENTS

Different visas might require different application documents. Some visa type's required documents are listed below. For a different visa type and any other documentation that may be necessary, we recommend you contact the local embassy.

HOLIDAY PURPOSE (FAMILY/FRIENDS/HOTEL)

Visa for transiting purpose allow the applicant to stay in Fiji up to an initial 4 months

1. Completed [Visitors Visa Application form](#)
2. Certified copy of the passport
3. Two recent passport size photos

4. Confirmation of pre-booked hotel
5. A copy of the travel itinerary/ticket
6. Proof of funds to sustain duration of stay (e.g. recent Bank Statement/Visa Cards)
7. Copy of sponsor valid I.D/passport/ permit
9. Proof of approved visa and onward ticket (if applicant is travelling to another country needing visa)
10. Consent letter from spouse (if travelling alone)
11. Consent letter from parents (for 18 years and under)
12. Leave letter is approved
13. Proof of relationship (Marriage Certificate/Birth Certificates)

TRANSITTING PURPOSE

Visa for transiting purpose allow the applicant to stay in Fiji from 3 hours to 72 hours.

1. Completed [Visitors Visa Application form](#)
2. Certified copy of passport
3. Two passport size photos
4. Proof of onward ticket to the next destination and another outward ticket if travelling out of that destination.
5. Proof of approved visa/permit for the next destination

BUSINESS/TRAINING/WORKSHOP PURPOSE

Visa for transiting purpose allow the applicant to stay in Fiji for up to 14 days.

1. Completed [Visitors Visa Application form](#)
2. Two certified photos

3. Certified copy of passport
4. Sponsor letter if a local company/organization is sponsoring to indicate the undertaking person for the duration of his period
5. Letterhead with specific subject (single-entry or multiple entry-visa)
6. Purpose of visit (business/workshop/training)
7. Intended duration of stay or program duration
8. Location of undertaking (where will the business/workshop/training take place)
9. Outline of business/workshop/training to be undertaken
10. A copy of the travel itinerary/ticket

4. PROCESSING TIME AND FEES

Processing Time takes 3 working days to process visa applications from the date of receipt by the Visa Officer. The delay in processing may occur when the applications submitted are incomplete or further clarification, additional documentation or verification of documents are required.
