1. GENERAL INFORMATION

Where can I get a Nigerian visa?

You can apply for a visa to Nigeria at a local Consulate or Embassy, or you can apply online, albeit online visa applications are only valid for certain types of visas. Please contact the consulate if you have any questions about your application or the validity of making application online.

2. VISA TYPES

Short Visit Visas

For tourism, transit, social visit to family and friends, exchange, journalism, religious visits, sports visits, entertainment, some business activities and etc.

3. TOURIST AND VISITOR'S VISA

- Tourism Visa is a single-entry visa for the purpose of tourism in Nigeria.
- Citizens of all countries except the Economic Community of West African States (ECOWAS) member States and other countries which Nigeria has entered into visa abolition/waiver agreements can apply tourist visa.
- *Valid for no more than 90 days* from the date of issuance.
- Online application may have different types of requirements and process, so it is highly recommended to contact with the relevant consulate or embassy.

REQUIREMENTS:

1. Passport *valid for at least 6 months* with at least 2 blank visa pages for endorsement
2. Two recent passports sized (35/40mm) photograph
3. Return ticket
4. Evidence of sufficient fund
5. Evidence of Hotel Reservation/host address in Nigeria

4. TEMPORARY RESIDENCE VISAS FOR ACADEMIC PURPOSES

Temporary Residence Visas allow individuals reside in Nigeria for a period *not exceeding two years*.

4.1 ACADEMIC EXCHANGE PROGRAM (STUDENT, SCHOLAR, LECTURER) VISA-F7H

Academic exchange program visa is a *single-entry visa* issued for the purpose of academic exchange program. Students, scholars and lecturers are eligible to apply academic exchange program visa.

REQUIREMENTS:

1. Passport *valid for at least 6 months* with at least 2 blank visa pages for endorsement
 2. Invitation letter from Institution in Nigeria
 3. Return ticket
 4. Evidence of sufficient funds
 5. Evidence of hotel reservation/host address in Nigeria
- Visa is *valid for not more than 90 days* from date of issuance
 - Applicant is only permitted to perform academic exchange program. Applicant could not work or schooling
 - Visa can be applied at *Embassy and online* (Nigeria Immigration Service)

4.2 INTERNS VISA-R9A

Interns visa is *multiple-entry visa* issued to persons who wish to undergo resident internship program in Nigeria.

REQUIREMENTS

1. Passport *valid for at least 2 months* with at least 2 blank visa pages for endorsement
 2. Letter of acceptance of internship by institution in Nigeria
 3. Visa Validity
 4. Valid for not more than 90 days from the date of issuance
- The duration of stay is 1 year residence permit
 - Permitted activities are to undergo resident internship program in Nigeria. Applicant could not permitted for work
 - *Visa can be applied at Embassy*

4.3 STUDENT VISA-R7A

Student Visa is issued for the *purpose of schooling in Nigeria*.

International Students are eligible to apply student visa.

REQUIREMENTS

1. ***Passport valid for expected duration of study*** with at least 2 blank visa pages for endorsement
 2. Admission Letter from an accredited institution
 3. Formal application for R7A Visa by the Institution accepting Immigration Responsibility
 4. Proof of payment of required minimum tuition fee
- Visa is valid for not more than 90 days from the date of issuance
 - Permit type and duration of stay is residence permit 2 years
 - Applicant permitted to school in Nigeria but not permitted to work
 - Visa can be applied in embassy

5. TRANSIT VISA



TRANSIT VISA- F3B

- Transit Visa - F3B is for the passengers with onward ticket to the next destination. Transit visa is also in the category of ‘Short Visit Visa’.
- Transit Passengers who have onward ticket to the next destination where entry is guaranteed and wish to enter Nigeria before proceeding on the onward journey can apply transit visa.
- ***Onward ticket to the next destination is the only general requirements.*** To see if there is any other required documentation, please contact with the relevant consulate or embassy.
- Visa validity period is 1-7 days and not exceeding 7 days
- This visa is valid for single-entry
- Transit visa can be applied at Embassy and online (Nigeria Immigration Service)

TRANSIT WITHOUT VISA- F3A



- Transit without visa is for transfer/direct transit passengers ***not staying beyond 48 hours***.
- ***Onward ticket*** to the next destination is the only general requirements. To see if there is any other required documentation, please contact with the relevant consulate or embassy.
- Permit type and duration of stay is ***48 hours maximum***
- Permitted Activities are connected flight to the next destination, transfer/direct transit. And it is ***not permitted to go outside the airport***.

Important Note: Before trying to make a transit without visa through Nigeria, please make sure with contacting relevant consulate about if there is any changes in those regulations. Because the information may change.

The Application Process:

1. Login to the Nigeria Immigration Service
2. Click "Create New Application"
3. You can book an appointment after finishing your application form. Track your application (You can track your application with entering the system and using Application, Reference no.)
4. Make payment (You will be seeing the fee while making an application)

Important Note: Some visa types are unable to be applied for through the online visa application system
