# 1. GENERAL INFORMATION

Applications for Papua New Guinea visa applications are made from the Australian consulates since they do not have a consulate within the borders of Turkiye. If you are going to apply from another country, we strongly recommend that you research the exemption of the e-Visa and the consulates in your region.

The role of Australian embassy in Turkiye is limited to issuing a visa once they receive approval from Papua New Guinea Immigration and Citizenship Authority.

Once they receive visa approval from Papua New Guinea Immigration and Citizenship Authority, then they will process the visa.

- Validity of a *Student Visa* is subject to the individual circumstances of the applicant. Student visa applicants should submit their application using the paper form; to see the form, please [click here](#).
- *Visitor Visa* is valid for a single-entry stay of sixty (60) days from the date of arrival.
- *Citizens of the Republic of Turkiye* who will travel to Papua New Guinea with diplomatic, service, special and ordinary passports *are need to obtain a visa*. Citizens of other countries can contact the relevant consulate about whether a visa is required.

## 2. E-VISA SYSTEM

- Travelers with a passport from a country that is eligible for a visa on arrival may apply online using the electronic visa portal. To see, the list of nationalities who are eligible for a visa on arrival, please [click here](#).

- For *Turkiye*, there is *no exemption to apply through online E-visa system*. Please contact with the relevant consulate to apply for a visa to Papua New Guinea.

### 3. GENERAL REQUIREMENTS

Tourists and visitors can obtain entry permits for *up to two months*, provided they satisfy the general conditions mention above. Persons entering for other purposes except non-working entrants also must state the purpose of their visit when lodging the request for an entry permit.

- Have a return or onward airline ticket to a destination beyond Papua New Guinea and authority to enter there in

- Have funds to maintain themselves (K300.00 a month) or will be maintain by relatives
- They do not engage in any form of employment whether paid or unpaid
- Any other conditions that may be imposed on arrival

**Important Note:** Before making an application, please contact with the local consulate or embassy.
