1. GENERAL INFORMATION

Do I need a visa to visit Uzbekistan?

You can visit the website of the Embassy in Turkiye to see some regulations about obtaining a visa to visit Uzbekistan. To see the website, please *click here*.

Turkish citizens are allowed to visit Uzbekistan without having a visa for *up to 30 days*.

Important Note: For some diplomatic visa holders, may have other rules about visa exemption. Please, contact with the nearest consulate to get information before making application.



2. VISA TYPES

T- TOURIST ENTRY VISA

• It is issued for up to 1 month to foreign citizens visiting the Republic of Uzbekistan for tourism purposes.

STD- STUDENT ENTRY VISA

• Student entry visa (on the basis of interuniversity exchange - for the period of temporary study) is issued for up to 1 year to foreign students studying on a short-term basis (on a temporary basis according to interuniversity exchange or as part of interuniversity cooperation) in educational institutions (higher educational institutions) located on the territory of the Republic of Uzbekistan.

A1-STUDY ENTRY VISA

• Study entry visa (on a permanent basis - for the period of study) is issued for a period of up to 1 year to foreign citizens studying in educational institutions located on the territory of the Republic of Uzbekistan.



TRAN-TRANSIT VISA

• Transit visa is issued for up to 3 days to foreign citizens following in transit through the territory of the Republic of Uzbekistan.

B1- BUSINESS ENTRY VISA

• Business entry visa (accredited at the relevant departments and institutions of the Republic of Uzbekistan) is issued for the period of accreditation to members of representative offices of foreign commercial organizations, as well as foreign banks or other financial organizations in the territory of the Republic of Uzbekistan.

3. GENERAL REQUIREMENTS

List of required documents to invite foreigners by organizations and companies:

- Visa application on Head letter of organizations and companies
- E-form of the site evisa.mfa.uz
- Copies of passports of the invited person, head of the organization, authorized person of organization to submit the documents
- Copies of documents of the organization (license, certificate, etc.)
- Copies of orders to the head and the authorized person
- Copy of Power of Attorney for the authorized person
- For arrival visa at the airport "Tashkent" should be provided copies of tickets
- Certificate of employment of the invited person



In order to apply for the visa, foreign citizens and stateless persons are to submit the following documents to the diplomatic representation or consular mission of Uzbekistan abroad:

- Passport or document of stateless person, expiry date of which must exceed the visa's period of validity not less than 3 months;
- 2 copies of duly completed visa application form;
- 2 passport-size-colored photos.

<u>Important note:</u> For a transit visa foreign citizens and stateless persons in addition to the above-mentioned documents must have a visa of the country of final destination and travel documents with confirmed date of departure from Uzbekistan. In this case processing of visa application is 3 working days.



4. OFFICIAL ELECTRONIC VISA PORTAL OF THE

REPUBLIC OF UZBEKISTAN



- E-visa portal is making the application for tourist and short-term visit visa easier to apply. The countries and nationalities which have to obtain a visa to visit Uzbekistan may use the E-visa portal to apply easily.
- Turkish citizens are not having to use the E-visa portal to apply, because they do not have to obtain a visa to visit Uzbekistan in a short-term visit

5. VISA FEES

FOR SINGLE-ENTRY VISAS:

Duration of Stay	Fees	Duration of Stay	Fees
Up to 7 days	\$40	Up to 3 months	\$80
Up to 15 days	\$50	Up to 6 months	\$120
Up to 30 days	\$60	Up to 1 year	\$160

Important Note: Note: For each additional entry the fee shall be increased by \$10.

FOR MULTIPLE-ENTRY VISAS:

Duration of Stay	Fees
Up to 6 months	\$150
Up to 1 year	\$250



FOR TRANSIT VISAS:

Duration of Stay	Fees
Up to 72 hours	\$40
Double-entry transit visa	\$50

• Except these fees the fees for reimbursement of actual expenses related to the visa issuance (administrative fees) will also be paid. The rates of these fees depend on the place of visa issuance.

<u>Important Note:</u> Different procedure for issuance of entry visas may be applied to the citizens of those countries that have appropriate bilateral agreements with Uzbekistan.
