1. GENERAL INFORMATION

Do I need a visa to go to Moldova?

Turkish ordinary passport holders, holders of Diplomatic, Service and Special Passports are *exempt from the visa for 90 days*.

If you are not a Turkish citizen, please contact the local embassy to get information.

How can I make an application for visa?


Visa applications are submitted to diplomatic missions and consular offices of the Republic of Moldova or through the *e-Visa service*, governmental portal, intended only for the short-stay visa.



2. SHORT-STAY VISA (TYPE C)

Allows foreigners to request entry to the Republic of Moldova's territory for reasons other than immigration for an uninterrupted stay or several *stays of no more than 90 days during any 180-day period* preceding each day of stay on the Republic of Moldova's territory.

2.1 Mission (TYPE C/MI)

This visa is intended for those who work in governments, public administrations, or international organizations, as well as those who, as a result of their stay in the Republic of Moldova, are interested in the country's connections with the state of belonging. This visa is also available for accompanying family members.

Required Documents:

- Passport (issued within *the last ten years*) whose validity exceeds by *at least 3 months* the expected date for leaving the territory of Moldova
- 2. A color photograph (35mm x 45mm)
- 3. Proof that he performs functions within governments, public administrations or international organizations or shows interest in the relations between the Republic of Moldova and the country of affiliation
- 4. The approach from the institution or authority from abroad or from Moldova that certifies the travel to the Republic of Moldova for reasons related to their political, administrative or public utility function



2.2 Tourism (TYPE C/T)

This visa is for foreigners who are going to travel to Moldova for tourism.

Required documents:

- 1. Passport (issued within *the last ten years*) whose validity exceeds by *at least 3 months* the expected date for leaving the territory of the Republic of Moldova
- 2. A color photograph (35mm x 45mm)
- 3. Accommodation commitment
- 4. The travel itinerary (the tourist route on which the trip is to be carried out, with the indication of the localities along the way)
- 5. The invitation issued by the competent authority for foreigners or the presentation of the residence permit or a valid visa issued by one of the member states of the European Union or of the states party to the Schengen Agreement
- 6. Reservation of a round-trip ticket valid to the destination
- 7. Medical travel insurance valid on the territory of the Republic of Moldova (minimum coverage is 30,000 euros)
- 8. Proof of means of maintenance during the stay (30 euros/day, for the entire requested period, but not less than 300 euros)



2.3 Cultural, Scientific, Humanitarian Activities, Short-term Medical Treatment or Other Activities That Do not Contravene National Laws (TYPE C/AD)

This visa is for having a condition of presence in the Republic of Moldova within the terms of the justification for presence.

Required Documents:

- 1. Passport (issued within the *last ten years*) whose validity exceeds by *at least 3 months* the expected date for leaving the territory of the Republic of Moldova
- 2. A color photograph (35mm x 45mm)
- 3. The invitation issued by the competent authority for foreigners or the presentation of the residence permit or a valid visa issued by one of the member states of the European Union or of the states party to the Schengen Agreement
- 4. Reservation of a round-trip ticket valid to the destination, or the driver's license, green card and registration documents of the means of transport, in the case of drivers
- 5. Proof of means of maintenance during the stay (30 euros/day, for the entire requested period, but not less than 300 euros)
- 6. Medical travel insurance valid on the territory of the Republic of Moldova (minimum coverage is 30,000 euros)
- 7. Proof of ensuring the accommodation conditions



3. LONG- STAY VISA (TYPE D)

• Allows foreigners to stay on the territory of the Republic of Moldova for a period of *no more than 12*

months, for one or more stays of no more than 90 calendar days during any period of 180 calendar days, considering the last period of 180 days preceding each day of stay, allowing the foreigner to request the granting of the right of stay.

• Long-term visas are given based on the activity to be performed in the Republic of Moldova. Long-stay visas can be given for the following purposes: Entrepreneurial activity, employment, studies, family reunification, humanitarian or religious activities, diplomatic and service activities, treatment, and information technology activities.



3.1 STUDIES (TYPE D/AS)

Long-term study visas are issued to foreign nationals who intend to study at a pre-university, university, or postgraduate level in the Republic of Moldova.

Required Documents:

- 1. Passport (issued within *the last ten years*) whose validity exceeds by *at least 3 months* the expected date for leaving Moldova
- 2. A color photograph (35mm x 45mm)
- 3. Confirmation act from the educational institution regarding the acceptance to studies
- 4. Medical travel insurance, valid for the Republic of Moldova for the entire period of validity of the visa (Minimum coverage 30,000 euros)
- 5. Proof of means of maintenance for the entire period entered in the visa with the exception of foreigners on scholarships of the Republic of Moldova (in the latter case, proof of holding a scholarship in the Republic of Moldova) and participants in student exchange programs



- 6. The invitation issued by the competent authority for foreigners, or the presentation of a valid residence permit or visa issued by one of the member states of the European Union or of the Schengen Agreement party states
- The agreement of the parents or the guardian regarding the stay for the purpose of studies in the territory of Moldova, if the foreigner is a minor
- 8. Criminal record certificate translated into English or Romanian
- 9. Consular fee -40 euros (additionally the related fee established by the embassy or consulate will be paid)
- 10. In the case of foreigners participating in a student exchange program, in addition to the listed documents, the following will be presented: the copy of the agreement or understanding between the educational institutions that organize the program and the maintenance or accommodation commitment



4. AIRPORT TRANSIT VISA (TYPE A)

The following categories of people are exempt from the obligation to hold an airport transit visa:

- Aircraft crew members
- Holders of diplomatic passports and service passports or similar ones
- Holders of a valid residence permit or equivalent document issued by a member state of the European Union or the United States of America
- Holders of a valid visa issued by a member state of the European Union or the United States of America

Required Documents:

- 1. Passport (issued within *the last ten years*) whose validity exceeds by *at least 3 months* the expected date for leaving the territory of the Republic of Moldova
- 2. Authorization to enter the territory of a third country (except for foreigners who do not need a visa for that country)
- 3. A color photograph (35mm x 45mm)
- 4. Plane ticket valid to the destination


