1. GENERAL INFORMATION

Do I need visa to travel to Malaysia?

- Public, service, special, and diplomatic passport holders of Turkish citizens are exempt from tourist visa for 90 days.
- Passport validity periods of Turkish citizens who will travel to Malaysia must be valid for at least 6 months from the date of arrival. *Otherwise, entry into the country is not allowed*.

Important Note: If you are not a Turkish citizen, please contact the nearest consulate or embassy to get information.

2. TYPES OF VISAS

1. SINGLE-ENTRY VISA

• This is given to foreign nationals who need a visa to enter Malaysia, primarily for social purposes. It is usually valid for one entrance and for three months from the date of issuing.

2. MULTIPLE-ENTRY VISA

• This visa is granted to foreign nationals who need a visa to enter Malaysia for business or governmentto-government purposes. It is usually valid for three months to twelve months from the date of issue. The Multiple Entry Visa is valid for one year. Each entry is valid for 30 days and no extensions are permitted.

3. TRANSIT VISA

• This is given to foreign nationals who need a visa to enter Malaysia on their way to another country. Foreign nationals in transit who do not leave the airport and continue their travel to their next destination on the same flight do not need a transit visa.



3. GENERAL REQUIREMENTS

- 1. Two copies of visa forms to be filled and signed
- 2. A valid travelling document with at least 6-month validity
- 3. No Objection Letter from Company/Sponsors (for individuals/family members)
- 4. A Copy of Labor Contract or Salary Certificate of applicants/sponsors for spouse/children of sponsors
- 5. Two passport size photographs
- 6. Confirmed hotel booking

"The information may vary. It is therefore advised that you conduct your own research for up-to-date information."



- 7. Confirmed return ticket
- 8. Photocopy of passport
- 9. For Business visa, an invitation letter is required.
- 10. For multiple entry business visa, an interview would be conducted

Important Note: The above requirements contain the minimum required documents. Documents required may vary depending on your travel reason, more documents may be required. Therefore, it is important to get information from the relevant consulate before applying.

What is e-VISA?

E-Visa is an online application platform that allows foreign nationals to apply for an electronic visa to enter Malaysia at their leisure.

The required documents are usually the same as the "General Requirements".

How long will my e-VISA for Tourist (Social Visit) be valid for?

E-Visa is *valid for 3 months* while e-Visa holder is entitled to stay for the total of days subjected to the eligibility of e-Visa holder nationality for each visit to Malaysia.

Important Note: Turkish citizens do not have to use e-Visa system, they are allowed to visit Malaysia without obtaining visa for 3 months.


