1. GENERAL INFORMATION

Do I need a visa to go to Bolivia?

Turkish citizens with official and ordinary passports are *exempt from visa for 90 days* when they enter Bolivia.

Other nationalities should contact the local embassy and consulate' to get information about exemption of visa.

2. REQUIRED DOCUMENTS FOR VISA EXEMPT ENTERANCE

TRAVELLERS WHO EXEMPT FROM OBTAINING VISA MUST SHOW:

- Hold a passport valid *at least six months* on entry with one blank visa page
- Hold proof of sufficient funds
- Hold proof of onward/return flights
- Hold all documents required for the next destination
- Hold a valid yellow fever certificate if arriving from a country with risk of yellow fever transmission or if travelling to high-risk areas

3. GENERAL REQUIREMENTS

1. [Visa application form](#), obtained from the websites of the general directorate of migration, of the directorate general of consular affairs or in the representations consular offices where the visa is requested
2. Passport with a *minimum validity of six months*
3. Certificate of vaccination against yellow fever and/or another health certification, if applicable
4. Passport photograph

5. Proof of payment of the cost of the corresponding procedure, except those granted under state agreements or conventions

Important Note: There are also some *specific requirements* for obtaining visa. It is important to know that consulates may require other relevant documents if it is needed.

4. SPECIFIC REQUIREMENTS

For The Transit Visa:

- Tickets that prove that your final destination is a third country.

For the Tourist Visa:

- Travel itinerary, invitation letter from person with address legal in Bolivia or lodging reservation
- Financial solvency accredited by sworn declaration documentary supported

SPECIFIC REQUIREMENTS

For The Student Visa:

- ***Document that certifies the last level studies completed*** in school, institute or university of the country where the applicant resided, legalized by the corresponding consular office
- ***Original acceptance letter or legalized photocopy*** issued by the destination higher education institution. Applicable for visa as a student with a state or private agreement or agreement
- Legalized copy of the interinstitutional agreement or agreement according to applicable, where the type of exchange of students. Applicable for student visa with agreement or private agreement
- Current certificate that proves that the foreign person does not has a criminal and/or police record, issued by authority competent in the country of origin or of his last residence, of according to current regulations

SPECIFIC REQUIREMENTS

For Multiple Visa:

- Legalized documentation of the Company's Constitution to the that you represent in your country of origin or residence
- Legalized photocopy of the Tax Identification Number or original electronic certification in case the company has been established in Bolivian territory
- Current background certificate issued by Interpol
