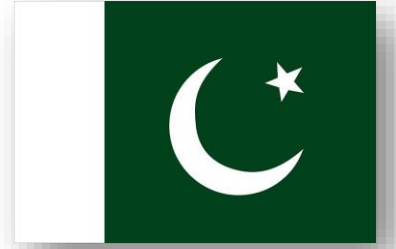

1. GENERAL INFORMATION

Do I need a visa to go to Pakistan?

Citizens of the Republic of Turkiye who hold diplomatic, service and special passports *are exempt from visa* for their travels to Pakistan *for up to 90 days within a year*.

Turkish citizens must apply to the Pakistan Embassy in Ankara or the Consulate General in Istanbul to obtain a visa appropriate to the purpose of their trip to Pakistan.

3. TOURIST VISA

A Tourist Visa allows the visitors to visit Pakistan for tourism purposes.

REQUIRED DOCUMENTS:

1. Dully filled-in visa form
2. Two passport-size photographs
3. Passport
4. Invitation Letter from the sponsor or hotel booking details in case of individual tourist
5. Invitation Letter in case of a group by the Tour Operator designated by the department of tourist services

DURATION AND VALIDITY:

- Applicant for a short duration *less than 3 months and the duration up to and greater than 6 months with extension*
- A Tourist Visa *can be extended to up to 6 Months or more*, subject to approval
- Processing Time of the visa is *7-10 working days*

4. TOURIST VISA (ON ARRIVAL)

To be available for the Tourist visa on Arrival, you must be a citizen of some relevant countries. To see those countries, please [click here](#).

REQUIRED DOCUMENTS:

1. Photograph
2. Passport
3. Invitation Letter from the sponsor or hotel booking details in case of individual tourist
4. Invitation Letter in case of a group by the Tour Operator designated by the department of tourist services

DURATION AND VALIDITY:

- Tourist Visa On Arrival is *valid for up to 3 months*
- Nationals of Bahrain, Kuwait, Malaysia, Oman, Qatar, Saudi Arabia, Turkey and UAE may be granted a *30-day, multiple-entry visa upon arrival*

Important Note: Please submit your intent to travel at least 48-72 hours before your planned trip to Pakistan to receive an **Electronic Travel Authorization.**

5. BUSINESS VISA

To be available for the Tourist visa on Arrival, you must be a citizen of some relevant countries. To see those countries, please [click here](#).

REQUIREMENTS:

1. Dully filled-in visa form
2. Two passport-size photographs
3. Passport
4. Proof of registration of company which is extending invitation

5. *Any of the following:*

- Recommendation letter from CC&I of respective foreign country
- Invitation letter from business organization duly recommended by concerned trade organization in Pakistan. To get this document, please apply through [*Pakistan's E-Business Invitation Letter System.*](#)
- Recommendation letter by the honorary investment counselor

DURATION AND VALIDITY:

- A Business Visa may be granted for *up to 5 years*
- A Business Visa is valid for multiple entries into Pakistan
- Processing Time is *up to 4-6 Weeks*

6. STUDENT VISA

- Prospective students who wish to pursue higher education in Pakistan can apply *for a 2-year* student visa.
- To be available for the student visa on arrival, you must be a citizen of some relevant countries. To see those countries, please [click here.](#)

REQUIREMENTS:

1. Dully filled-in visa form
2. Two passport-size photographs
3. Passport

4. Admission letter
5. NOC from HEC/ Economic Affairs Division/ IPC/ Health Ministry/ Education Ministry
6. For Entry Visa: NOC from the concerned Government
7. For Extension: NOC from concerned embassy in Pakistan of student's country
8. Sponsorship/ Bank Statement (in case of accompanying family)

DURATION AND VALIDITY:

- A Study Visa is ***granted for 2 years***
- Processing Time is ***4-6 weeks***

7. PAKISTAN ONLINE VISA SYSTEM



Can I apply to visa through Pakistan Online Visa System?

- Only nationals of the 191 countries can apply for the Pakistani visa through Pakistan Online Visa System.
- Turkish citizens could apply to visa through online visa system.

How to apply to visa with Pakistan Online Visa System?

1. ***Preliminary Assessment:*** Choose your visa type and understand the eligibility and document requirements before you apply.

2. **Preparation:** Complete set of supporting documents. Make ready your Photograph up to 350KB captured and ready your valid credit card for online payment of your application fee.
3. **Online Application:** Start your online application by visiting [the website of Government of Pakistan Ministry of Interior.](#)
