1. GENERAL INFORMATION

- Turkish citizens traveling for *90 days within 180 days* do not need a visa to enter Bosnia and Herzegovina. Bosnia and Herzegovina, which requires a security deposit as well as flight tickets and hotel reservation documents, follows the same procedure as 48 other countries around the world, including The Republic of Turkiye. Only citizens of Kazakhstan with diplomatic, special, or service passports are exempt from Bosnia and Herzegovina visa requirements.
- Apart from European Union members, the citizens of the following countries are exempt from visa requirements in Bosnia and Herzegovina: **Albania, Andorra, Antigua and Barbuda, Argentina, Azerbaijan, Australia, Bahamas, Bahrain, Barbados, Brazil, Brunei, Canada, Chile, Costa Rica, El Salvador, Guatemala, Honduras, Hong Kong, Israel, Japan, Kuwait, Macau, North Macedonia, Malaysia, Mauritius, Mexico, Monaco, Montenegro, New Zealand, Nicaragua, Oman, Panama, Paraguay, Qatar, Russia, Saint Kitts and Nevis, San Marino, Serbia, Seychelles, Singapore, South Korea, Taiwan, Turkiye, United Arab Emirates, The United States, Uruguay and Venezuela.**

- Citizens of these countries are permitted to stay in Bosnia and *Herzegovina for 90 days within a 180-day period* beginning on the date of first entry, provided they do not seek employment.
- However, Bosnia and Herzegovina requires a deposit of money, as well as flight tickets and hotel reservation documents, for security reasons.

- Most visa applications require an interview at the responsible consulate. It is important to bring the required documents as well as the original travel document after the confirmation of the online application.
- Bosnia and Herzegovina *visa is commonly issued within 7 business days*, but it can take up to 30 days if a detailed examination is needed or additional documents required.

2. VISA RULES

Many countries around the world can enter Bosnia and Herzegovina without a visa. If your country is not eligible for visa-free entry into Bosnia and Herzegovina, you must obtain a Bosnia and Herzegovina visa and follow the visa rules outlined below:

- People *under the age of 18* are required to present a birth certificate.
- The passport should be *no more than ten years old*.
- The travel document should be *valid for at least three months* from the date of expected arrival in Bosnia and Herzegovina.

3. C-TYPE (SHORT-TERM) VISAS

TYPES OF SHORT-TERM VISAS:

- Touristic Visa
- Business or Fair Participation Visa
- Family, Relative or Friend Visit Visa
- Cultural, Sports or Conference Visit Visa
- Short-Term Education or Internship Visa

4. D-TYPE (LONG-TERM) VISA

You can apply Long-Term Visa for the conditions of:

- A student who intends to attend a higher education institution, take a language course, or work on a long-term internship.
- An employee who is going to work for a company in Bosnia and Herzegovina an academic, researcher, or scientist to work in a research center.
- A person whose family member is a citizen of Bosnia and Herzegovina.
- A patient undergoing medical treatment in a Bosnia and Herzegovina medical facility.
- A private entrepreneur who is the founder of a legal or physical entity that will benefit Bosnia and Herzegovina economically.
- An athlete or sportsman who will compete in sporting tournaments, trainings, or events

5. VISA APPLICATION REQUIREMENTS

If your nationality does not qualify for visa-free entry into Bosnia and Herzegovina, you must present the following documents:

- Application form in PDF link filled in block letters
- Original and one copy of the passport
- A passport-sized photo
- Visa fee receipt
- A copy of the round-trip flight or another return ticket

There are additionally required or supporting documents from certain applicants:

Employed:

- Employment contract
- A letter from the company that states your absence, duration of the stay, and confirms returning to current job
- Bank statement of the last six months

Student:

- Proof of enrollment and no objection certificate from the registered school
- Sponsorship documents if the applicant cannot support himself/herself financially during the period of the stay
